Choate Summer Programs 2023 Financial Aid Information

- Choate Rosemary Hall seeks the best qualified candidates from a variety of backgrounds and offers need-based financial aid to students with strong academic performance and potential.
- Because of limited funds, Financial Aid is primarily only available for US residents filing IRS
 Income Tax Returns. The deadline for priority consideration for aid is February 14, 2023.

Financial Aid can help cover fees for academic classes and programs, but is not available for test prep courses.

Please note that priority in awarding of aid is given to qualified first-time applicants, and that receiving aid for one summer does not guarantee additional funding for subsequent summers.

Financial Aid applications must include copies of completed 2022 or 2021 1040 IRS tax forms, 2022
 W2 forms, and supporting documents for all custodial and non-custodial parents or guardians.
 Please remember to redact social security numbers from all IRS tax documents.

Current Choate students and students applying to Choate for the academic year must still comply with the Summer Programs financial aid process if interested in being considered for aid for Summer Programs. The Summer Programs Financial Aid application needs to be submitted, along with all the required tax forms and supporting documents for custodial and non-custodial parents.

Applicants whose admission and aid materials are complete on or before the priority deadline will
receive their decision soon after February 14, 2023. Applicants whose materials become complete
after February 14 will receive their decision on a rolling basis as materials are reviewed.

The Financial Aid application should be completed and uploaded to the Summer Programs Admission Portal, along with accompanying tax documents. Students will not be considered for Financial Aid until both the Summer Programs Financial Aid application and all IRS supporting documents have been received.
