Items Requested include but not limited to:

- Redacted Complaints about her conduct.

- Investigations into her conduct/misconduct.

- Disciplinary Actions against her.

- Any referrals and/or complaints made by the district to the SC Board of Education, SC Department of Education or SCLLR.

- A copy of her end of year from the 2020-2021 School Assisting, Developing, and Evaluating Professional Teaching (ADEPT) Final Evaluation

- Any interim ADEPT Goals-Based Evaluation (GBE) or Student Learning Objectives (SLOs) from the 2021-2022 School Year

- A copy of any evaluation or observation of her teaching performance

- A copy of her current position description

- Any supporting documents that reflect her qualifications to complete the job of Speech Language Therapist

- Any other document that would not constitute as "Information of a personal nature where the public disclosure thereof would constitute unreasonable invasion of personal privacy."

Unless a specific document is requested, the district can limit its search to the last twelve months.
