Dr Rodriguez,

Once again, I have been made aware of an illegal program that is being run in the Beaufort County School district. Over the last few months, a program called "Summer Institute" has been assembled, and teachers will be attending seminars to learn CRT based material to be taught in our schools.

I want to remind you that Proviso 1.108 STRICTLY prohibits this material to be drafted and/or disseminated to teachers and students in the State of South Carolina. This will be your one and only instruction to cease and desist this program. If you refuse, we will be following up with law enforcement against the entire school board and/or any school administrator or teacher that violates this.

I am also demanding that you provide me with the following information, that is covered under FOIA:

- List of administrators that reviewed and approved this material
- Date this material was approved
- Full details on the material (copies of the full agenda and materials)

It is pathetic that parents need to take the time to watch over the elected school board officials, and stand in front of our children to shield them from the poisonous and illegal behavior from the board and administration.
