POSITION DESCRIPTION

TITLE: ADMINISTRATIVE SECRETARY

TYPE: Classified

REPORTS TO: Designated Administrator or Director

POSITION SUMMARY:

The primary purpose of this position is to provide a variety of skilled secretarial duties in support of a secondary school or district department supporting specialty program or service.

MINIMUM QUALIFICATIONS:

1. High school diploma or equivalent.
2. Criminal history clearance.
3. Demonstrated basic skills through a local academic assessment.
4. Demonstrated secretarial skills as evidenced by district skills assessment.

ESSENTIAL FUNCTIONS:

1. Coordinate all functions of a department or secondary school in a specialty program or service.
2. Prepares documents, including memos, letters, reports, forms, etc. from dictation, rough draft, or by directive.
3. Receives, sorts, and distributes mail.
4. Receives telephone calls and serves as a receptionist, giving related information as necessary.
5. Creates and maintains files and database systems information in areas of responsibility.
6. Performs record keeping tasks as assigned.
7. Operates computers, calculators, copy machines, fax machines, and other office equipment.
8. Assists parents and community members as needed.
9. Attends training sessions and secretarial meetings as directed.
10. Works harmoniously with others and communicates effectively (both orally and in writing) with students, parents, and staff.
11. Works independently, prioritizing tasks to meet deadlines while maintaining a high degree of accuracy and attention to detail.
12. Operates a computer and views a computer screen for prolonged periods of time.
13. Frequent and prolonged talking/hearing conversations.

OTHER REQUIREMENTS:

1. Possible exposure to bodily fluids due to student or employee illness or injury.
2. Function where there is pressure, frequent interruptions, and a stressful atmosphere.
3. Work is almost exclusively indoors.
4. May be required to obtain a First Aid and/or CPR Card and serve as a Delegated Caregiver or Designated First Aid Provider.
5. Occasionally performs other duties as required by supervisor.

WORKPLACE EXPECTATIONS:

The employee has regular attendance at work and work activities, and is punctual in meeting deadlines, attending meetings, and following schedules.

The employee is dressed and groomed in a neat, clean, and appropriate professional manner for the assignment and work setting.

The employee maintains the integrity of confidential information relating to a student, family, colleague, or district patron. The employee uses or relays personal information only in the course of performing assigned responsibilities and in the best interest of the individuals involved.

The employee follows all district or supervisor policies, rules, regulations, memos, bulletins, announcements, applicable position descriptions, and reasonable requests by proper authority.

TERMS OF EMPLOYMENT:

Current work year of approximately 190-260 paid days, depending on position, subject to change.
Salary and benefits based on current District Salary Schedule and negotiated agreement.
