Re: Tomball ISD FICA Alternative Plan

Dear Employee:

You are receiving this letter because you are an employee in a position that is not covered by the Teacher Retirement System of Texas (TRS). This includes most part-time, seasonal or temporary employees with Tomball ISD. Effective January 1, 2017, Tomball ISD has elected to adopt the RAMS FICA Alternative Plan; this is also called a "Social Security Opt-Out Plan" or "3121 Plan" by some employers.

Effective on the January 10, 2017 pay period, you will no longer have a Social Security post tax deduction from your paycheck; you will make a pretax contribution to a FICA Alternative Account every pay period. The RAMS FICA Alternative Plan satisfies federal requirements and is offered to public school districts and other education agencies in Texas. Each participating Employer has designed its own tax-deferred plan for its employees through the Region 10 FICA Alternative (referred to as the "Plan" in this letter).*

What are the benefits of the FICA Alternative Plan?

- The contributions made to the FICA Alternative Plan are available to you at the time you terminate your services from Tomball ISD.
- Participants earn market rate of return on their contributions, and your funds are always 100% vested.
- Upon leaving the District, you are eligible to rollover the funds to another qualified retirement account.

What does this do to my paycheck?

Following is a sample paycheck illustrating how the deduction will affect a paycheck using a fictitious income.

This letter is to inform you about the details of the Tomball ISD RAMS FICA Alternative Plan effective January 1, 2017. *Here are the important things you need to know about this Plan:*

- 1. Effective January 1, 2017, TCG Administrators in Austin, TX will begin administering the Plan.
- 2. Matrix Trust will be the investment firm holding the FICA alternative funds for your district.
- 3. ESC Region 10 RAMS is the sponsor of the FICA Alternative program. The Plan will be controlled by Tomball ISD.
- 4. The FICA Alternative Plan is a retirement savings plan for part-time and substitute employees. You will be able to view

your account balance and information online at <u>www.region10rams.org</u>.

- 5. The Summary Plan Description, which includes the Plan rules and discloses Plan fees, can be found on the public portion of the website after the effective date.
- 6. Please review the enclosed RAMS FICA Alternative flyer for all details about the Plan including eligibility and distribution requirements.
- 7. Tomball ISD, TCG Administrators and Region 10 want to assure you that your account balance and records are secure. You will be fully invested at all times.

You will be able to see your account balance updated daily on the Region 10 RAMS website at <u>www.region10rams.org</u> after the first contribution has been made. <u>You may also call us toll-free at (800) 943-9179</u>.
