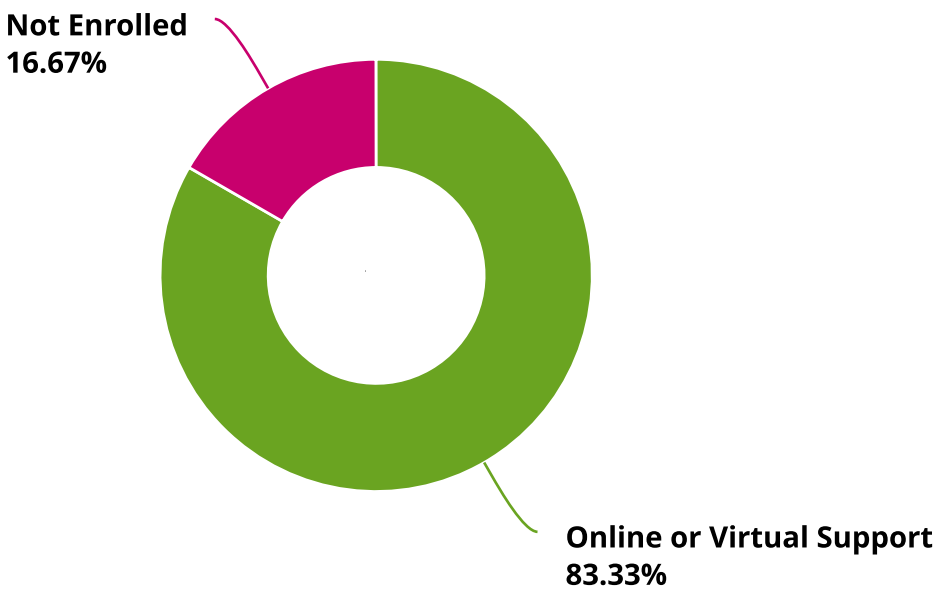
Onsite Support

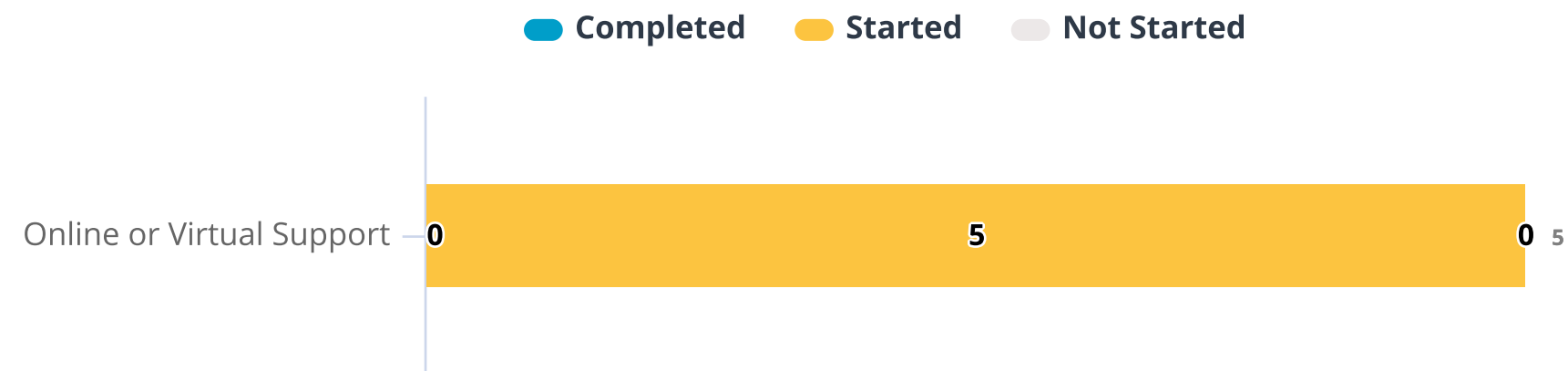

Assessment completion among enrolled schools, by grade level

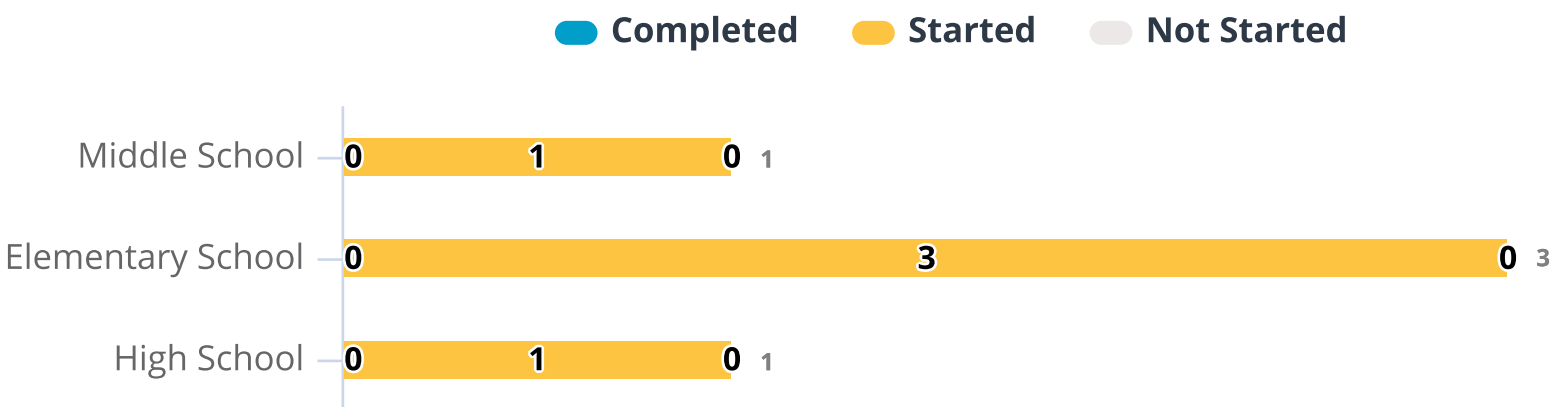


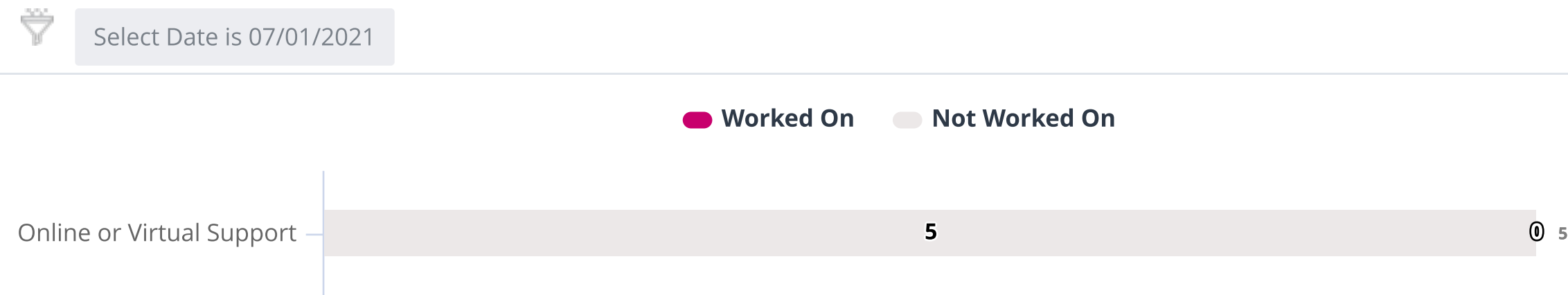

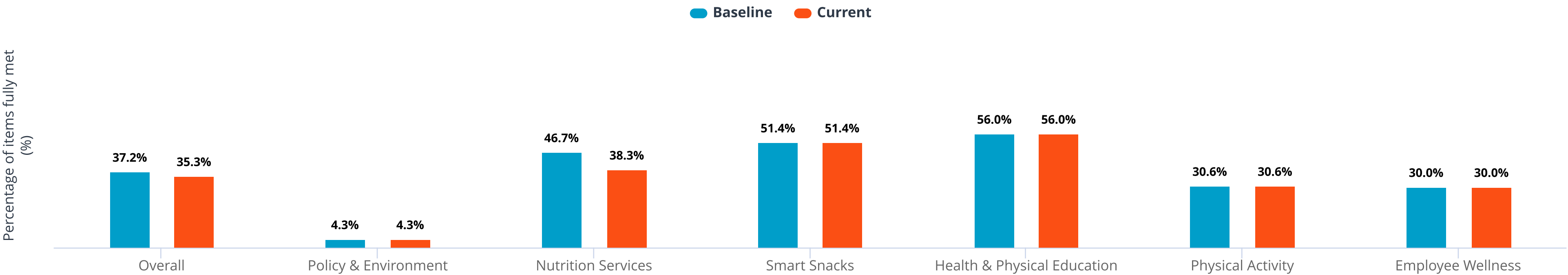
