61-12 GENERAL FUND APPROPRIATIONS

Mr. Fromel moved that the South Range Local Board of Education increase its General Fund Appropriation from \$11,466,712.00 to \$11,688,742.00 for FY12. Mr. Wince seconded the motion. All votes were yes.

62-12 ADOPTION OF THE FIVE YEAR FINANCIAL FORECAST

Mr. Wince moved that the South Range Local Board of Education adopt the revised five year financial forecast. The five year financial forecast is on file in the Treasurer's office. Mr. Pierson seconded the motion. All votes were yes.

63-12 FOOD SERVICE MANAGEMENT CONTRACT

Mr. Pierson moved that the South Range Local Board of Education adopt the following resolution:

WHEREAS, Ohio Revised Code Sections 3313.17 and 3313.81 empower a board of education to enter into contracts and establish a food service program, respectively; and

WHEREAS, the Board desires to procure food service management services to facilitate its participation in the United States Department of Agriculture's Child Nutrition Programs; and

WHEREAS, the Board followed certain procurement procedures in order to obtain such services; and

WHEREAS, with the approval of the Ohio Department of Education, the Board invited written proposals ("Request for Proposals") from qualified companies for the management of the school system's food service operation through a fixed cost reimbursement contract, which includes the following programs: School Breakfast Program, National School Lunch Program, a la carte items/meals, catering services, and special functions; and

WHEREAS, the Board has reviewed the proposals submitted by the food service management companies and determined that the proposal offered by The Nutrition Group is the most favorable and in the best interest of the South Range Local School District; and

NOW THEREFORE BE IT RESOLVED the South Range Board of Education authorizes the Superintendent, Board President, and Treasurer to enter into a contract with The Nutrition Group for the provision of food service management to the District for the 2012-2013 school year.

BE IT FURTHER RESOLVED that the Board authorizes the Treasurer to take all necessary steps to effectuate an agreement with The Nutrition Group for such food management services.

BE IT FURTHER RESOLVED that it is hereby found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
