D. Discussion of Special Education Unit Moving from South Vienna Elementary School to Rolling Hills Elementary School.

Mr. James opened the discussion with saying that Dr. Kronour has taken many things into consideration for the move of the special education unit. He said that Mrs. Kegley will be leaving the unit which was a concern of the parents that they stay with Mrs. Kegley.

Mrs. Parker confirmed that Mrs. Kegley would not be the teacher for these kids anymore (whether at South Vienna Elementary School or Rolling Hills Elementary School).

Dr. Kronour reiterated that he took many things into consideration before deciding to move the unit from South Vienna to Rolling Hills. He said that transition will always be a part of these students lives. He also said that this will help balance the number of special education students in the units throughout the district. He said that three of the kids moving from the South Vienna unit to Rolling Hills unit are already within the Rolling Hills Elementary school boundaries. He informed the Board that the aides the students had in 2015-2016 school year will be the same for the 2016-2017 school year which should alleviate some of the issues the students may have with the transition.

Mr. Augustus asked if friends from the general population students at South Vienna Elementary School could attend Rolling Hills Elementary.

Dr. Kronour said he would be open to that if there was available space in any of the classrooms at Rolling Hills.

Mr. James and Dr. Kronour said that they will contact the parents about the move.
