Projected winners named in Board election

The XVIII Board of Education of Charles County will be sworn in on Dec. 19 during a ceremony at St. Charles High School and will be seated for its first meeting on Jan. 10. The projected winners of the 2022 election include returning members Michael Lukas and David Hancock. New to their roles as Board members are Dottery Butler-Washington, Cindy Coulby, Nicole Kreamer, Yonelle Moore Lee, Jamila Smith. Brenda Thomas and Linda Warren.

Amira Abujuma, a senior at North Point High School, is the Student Board Member. Charles County Public Schools (CCPS) students vote for the Student Board Member in the spring, who serves from July to June each year.

The Maryland General Assembly passed legislation last year that changed the Board of Education election process. For the 2022 election cycle, two Board members were to be elected from each of the four Charles County Commissioner districts for a total of eight Board members to serve a four-year term.

One Board member was to be elected from the county at-large to serve an initial two-year term, and then is eligible to run for a four-year term in 2024. Elected Board members are limited to two terms.

Enrollment application open for charter school

Phoenix International School of the Arts, also known as PISOTA, is hosting virtual information sessions this month for community members interested in learning more about the new public middle school.

PISOTA will be the first public charter school within Charles County Public Schools (CCPS) and is scheduled to open in August 2023.

PISOTA will open in La Plata as a middle school serving students in Grades 6-8. Students must apply for enrollment consideration for the 2023-2024 school year.

Interested families can complete an application online at the PISOTA website.

In Maryland, public charter schools are part of their local school district with oversight of the local Board of Education. Maryland public charter schools are held accountable to the communities they serve, their local Board of Education and the Maryland State Department of Education. Charter schools are also publicly funded and do not require tuition or an entrance exam for students. PISOTA will have an arts-focused program of study using the Cambridge International Education curriculum that meets Maryland State Department of Education and CCPS course and assessment requirements.

The virtual information sessions are scheduled for Monday, Nov. 21, and Tuesday, Nov. 29, both at 6 p.m. Participants will need an active Zoom account to join the sessions. North Point High School salon is open and booking appointments

North Point High School students in the cosmetology Career and Technical Education (CTE) program, under the direction of two instructors who are licensed cosmetologists, study to earn a Maryland State Board of Cosmetologist license. The license is one held by professional stylists and others in the cosmetology field allowing them to work in the industry.

In Maryland, a person must log 1,500 hours of training and pass a written exam to obtain the license. North Point cosmetology students who are juniors and seniors gain that training in the school's salon.

Open to the public, students are taking appointments for salon services — hair, nail and skin care, along with texture and hair coloring services.

"It is important that students get to work hands on because it gives them real world experience and prepares them for the workforce. Working with diverse clients helps the students to feel confident and prepared in the industry on a professional level," Erin Glover, cosmetology teacher, said. "It also familiariz-

es them with a variety of different people and personality types."

The salon is open by appointment only. Appointments are open 12:30 p.m. on Mondays and Wednesdays, and from 12:30 to 3:30 p.m., on Tuesdays and Thursdays, with the last appointment booked at 3:30 p.m. Cash and credit payments will be taken at the time of service. Customers can book an appointment online here. Those who are not North Point students or staff must follow Charles County Public Schools (CCPS) visiting procedures and show photo identification before entering the building.

Once inside, customers will sign in at the main office and be escorted to the cosmetology salon. Only clients who are receiving salon services are permitted in the school. Salon services will be done under the supervision of the program instructors who will also pair the customer with a student who is best suited for the requested service. The North Point salon has been open for clients for about eight years with school staff, students and their families as customers, Glover said.

To be a licensed cosmetologist in Maryland a person must be at least 17 years old and have completed the ninth grade or received a GED. They must also submit proof that they have undergone 1,500 hours of training at a cosmetology school or have spent 24 months as a registered apprentice in a licensed beauty salon.
