





Annual Closing Distribution



- Of these, groundwork is underway on more than 500 lots within 7 subdivisions














Biking & Walking Safety

NOVEMBER 2 BOND ELECTION?

 CES, TCES, TES




Plan Analysis

- Boundary adjustments tend to be more emotive rather than analytic
- While keeping all students at the center of the decision-making process, we must look at the data to support each plan
- Also keeping new school boundaries and potential future adjustments in consideration


