**RESOLUTION CANVASSING RETURNS  
OF VOTES OF SCHOOL DISTRICT SPECIAL ELECTION**

BE IT RESOLVED by the School Board of Independent School District No. 272, State of Minnesota, as follows:

1. It is hereby found, determined and declared that the special election of the voters of this School District held on November 8, 2022, in conjunction with the State General Election, was in all respects duly and legally called and held.

2. As specified in the attached Abstract and Return of Votes Cast, at said election a total of 32,054 voters of the School District voted on the question of revoking the existing referendum revenue authorization of the School District and replacing that authorization with a new authorization for taxes payable in 2023 and thereafter (SCHOOL DISTRICT QUESTION 1), of which 16,922 voted in favor, 9,813 voted against the same, and there were 2,419 completely

blank or defective ballots. Said proposition, having (not) received the approval of at least a majority of such votes, is hereby declared to have carried.

3. As specified in the attached Abstract and Return of Votes Cast, at said election a total of 32,054 voters of the School District voted on the question of renewing the existing capital project levy authorization for taxes payable in 2025 and thereafter (SCHOOL DISTRICT QUESTION 2), of which 17,950 voted in favor, 8,555 voted against the same, and there were 2,649 completely blank or defective ballots. Said proposition, having (not) received the approval of at least a majority of such votes, is hereby declared to have carried.

4. The Clerk is hereby directed to certify the results of the election to the County Auditor of each County in which the School District is located in whole or in part. The Clerk is further directed to notify the Commissioner of Education of the results of the special election within fifteen (15) days following the adoption of this resolution.
