746.1305(a)(1) Pre-service Training- Developmental Stages	Pre-service training should be viewed as a support to the caregiver who has taken on the responsibility of caring for children for the first time. Research indicates without some basic understanding of children and how to work with them, the health, safety, and well-being of the children in care are at risk.
746.603(a)(8) Tracking System or Sign-in and Sign-out Logs	It was explained that attendance is very important and needs to be done as it is happening. I explained that if parents forget to sign their kids in or out the operation still needs to have a system in place to ensure the child is signed in and or out appropriately.
746.1203(2) Responsibilities of Caregivers - Know Group Responsible For	Research has shown that when caregivers have fewer children to supervise and the group size is limited it reduces the likelihood of injuries and illness in children and increases opportunities for positive interaction with children.
746.801(10) Required Records Maintained and Made Available - Safety Documentation for Emergency Drills, Fire Extinguishers, & Smoke Detectors	We recommend that you practice your drills at different times of the day and even naptime to include children and caregivers engaged in different activities. All staff and children should be able to evacuate in under three minutes.
746.2607(1) Activities for Pre-Kindergarten Age - Outdoor Play	You may accommodate weather, air quality, and seasonal changes by adjusting the scheduled outdoor time, the length of time outdoors, and children □s clothing. A chance to play outdoors every day helps keep children healthy. Fresh air in a large space contains fewer germs. Outdoor play also provides a wider variety of opportunities for sensory stimulation through sounds, smells, and textures.
746.3407(12) Mark Cleaning Supplies, Toxic Materials; Keep Separate from Food and Inaccessible to Children	Cleaning supplies pose a deadly health risk to children and must be stored in a manner that children have no access to them. Ensuring all cabinets that store cleaning supplies are locked and that cleaning supplies are inaccessible to children can help prevent accidental poisoning.
