- C. PUBLIC HEARING to receive public comment regarding the development of a school board election redistricting plan.
- D. DISCUSSION AMONG BOARD MEMBERS regarding school board election redistricting options "L" and "M" and matters relating thereto; and possible motion, second, and vote to approve a school board election redistricting plan. Oklahoma law requires school districts to reapportion board districts by December 31 of the year following the official Federal Decennial Census submission.
- E. RECOMMENDATION: Adopt a resolution calling a board member election for Election District Number One on April 4, 2023, for a general election, and, if necessary, a primary election on February 14, 2023; authorizing publication of a legal notice of board member election; posting of the legal notice of board member election at the Charles C. Mason Education Service Center and the county election board offices; and authorizing a press release of the filing period for board member elections; and to take all other actions required by law.

FURTHER RECOMMEND: Reimburse the Tulsa County Election Board for expenses associated with the election.

COST: Not to exceed \$50,000

FUND NAME/ACCOUNT: General Fund, 11-0000-2314-503100-000-000000-000-09-091

RATIONALE: The annual school resolution must be filed with the Tulsa County Election Board no later than November 18, 2022. Payment for expenses includes equipment, supplies, postage, legal publication, etc. Election expenses during the 2021-22 school year totaled \$39,371.45.
