Texas Supreme Court Rules School Funding System is Constitutional – May 2016

- Urging state lawmakers to implement "transformational, top-to-bottom reforms that amount to more than Band-Aid on top of Band-Aid."
- Legislature needed to decide what if anything to do
- HB 21 \$351 million into schools & created the school fiancé commission
- Disappointed" House accepts Senate's changes to school finance bill
 - The Texas House voted Tuesday to swallow a bitter pill and accept a version of a school finance bill that had \$1.5 billion less in funding for schools than the lower chamber initially approved.

Finance Commission

85th Interim Session

- Started in January of 2018, the commission made up of 15 members worked for a year to come up with meaningful recommendations
 - Create a long-term systemic balance between the state and local share of district foundation funding for public education
 - Substantially increase the level of equity in the system with significantly greater investment in low income and other historically underperforming student groups to markedly grow their educational outcomes by the year 2030
 - Significantly reduce the growth rate of property taxes and reliance on recapture as a method of finance for the state
 - Encourage widespread adoption of data-informed best practices that deliver improved results for students
 - Immediately infuse, net of property tax relief and new funding needed for student growth, significant additional state resources to fund the data-informed strategies that will improve student outcomes
 - Formulaically increase per pupil funding in the future (relative to current law) as outcomes-based funding grows from the successful investments in early learning, teacher quality, and high school supports made possible by the implementation of these recommendations

- Huberty and Taylor Introduce HB 3 The Texas Plan 03/05/2019
- The \$11.6 billion school finance measure includes about \$6.5 billion in new public education spending, plus about \$5.1 billion devoted to lowering Texans' property tax bills.
- The spending will increase per-student base funding by about 20%. It includes money to give teachers raises, fund free full-day pre-K for eligible 4-year-olds and reduce the amount of money wealthy districts must spend to subsidize poor districts through the state's recapture program, known as "Robin Hood."
- Abbott signs HB 3 06/12/19 stating, "We did something that was considered to be highly improbable, and that is to be able to transform public education in the state of Texas without a court order forcing us to do so.

- Recapture cut from \$3.6B to \$2.0B in year one

Budget and Compensation Increases



Basic Allotment Increased from \$5,140 to \$6,160

District Budget Increases



- This increases the minimum salary schedule (MSS) by \$5.5K - \$9K per creditable year of service (CYS)
- Teacher Retirement System (TRS) contributions from the state for all who are subject to the MSS will be increased, reducing the amount LEAs fund out of their own budgets

Educator Compensation Increases



- ✓ 30% of a district's budget increase must go to increases in compensation
 - 75% of this total must go to teachers, librarians, counselors, and nurses, with priority given to veteran classroom teachers (greater than 5 years experience)

Teacher Retirement System (TRS) payments for Charters and Districts of Innovation (DOI) now match those of ISDs



HB 1525

87th Legislative Session

- HB 1525 Clean Up Bill for HB 3
- House Bill (HB) 1525, passed by the 87th Texas Legislature and signed into law by Governor Abbott on June 16, 2021, provides additional Foundation School Program (FSP) funding to local educational agencies (LEAs) to ensure compliance with federal requirements regarding maintenance of effort and state-level maintenance of equity (MOEquity).


Foundation School Program

	~			
Career & Technology Allotment	Changes Career & Technical Education (CTE) funding from one weight of 1.35 per FTE to a system of tired weights related to courses (1.1 for non-approved programs, 1.28 weight for approved CTE programs for levels 1 & 2, and 1.47 for approved CTE programs for levels 3 & 4).			
	Entitles small and mid-sized districts to full CTE funding.			
Gifted & Talented Allotment	Entitles schools to a weight of 0.07 for each identified GT student served. Not more than 5% of students are eligible for this funding. Funding is capped at the amount appropriated: \$100 million per year.			
Fast Growth Allotment	Changes the current weight of 0.04 per ADA for every district in the top quartile of growth to instead entitle schools to an applicable weight for enrollment growth exceeding 250 students over a six-year period; weight is determined by ranking eligible districts, with the top 40% receiving the highest weight and the next 30%, and lowest 30% to qualify. For school year 2021-22, the weights would be 0.45, 0.30, and 0.15. The weights would increase to 0.48, 0.33, and 0.18 beginning with the 2022-23 school year.			
	Allotment distribution may be prorated if funding required exceeds maximum amount set in statute, which will be \$320 million per year by 2024-25, with a specified schedule increase gradually until then. \$40 million is specified to provide some transitional aid in 2021-22 for the difference between entitlements for this allotment under prior and new law.			
CCMR Bonus	Adds qualification for the College, Career, Military Readiness (CCMR) Outcomes Bonus for students earning an associate degree from a THECB approved institution while attending high school (or within a certain determined period).			
Comp Ed Allotment	Entitles districts to the highest possible compensatory education weight for each enrolled student who is homeless. Allows use of comp ed funds to pay for an instructional coach to help disadvantaged students duties performed by attendance officers, & programs to build skills related to social emotional wellness.			
Formula Transition Grant	Beginning in the 2021-22 school year, limits Formula Transition Grant funding to an amount that may not exceed \$400 million per year; grant amounts would be proportionally reduced for all districts if the total funding exceeds that capped amount.			
ΜΟΕ/ΜΟΩ	Allows Commissioner to increase school district and charter funding entitlements to ensure compliance with Maintenance of Effort (MOE) and Maintenance of Equity (MOQ) in federal legislation. (\$396 million

State Revenue Picture

The 88th Legislature will have access to huge surpluses as it writes the budget for the next two years:

- \$26.9 billion surplus in General Revenue-Related (GR-R) funds,
- \$13.7 billion in the rainy day fund, and




 \$3 billion in federal dollars from the American Rescue Plan.

The \$26.9 billion surplus in GR-R is a **\$15 billion increase** from Hegar's last forecast, which was published last November.

Disaster spending and tax relief is exempt.

Pay-As-You-Go





Basic Allotment

- The Basic Allotment (BA) is the basic per-student amount that serves as the basis for the Foundation School Program.
- In a year in which the BA is increased, current law requires that 30% of the overall year-over-year increase go to teacher compensation increases.
- BA increase would also trigger copper penny compression.
- Growing consensus on need to link BA to some measure of inflation.



Fund based on services provided rather than instructional setting







School Safety

Earlier this summer, Gov. Abbott announced **\$105.5 million** to support school safety and mental health initiatives. Some of the major items include:

\$50 million for bullet-resistant shields (deadline has passed);

- \$17.1 million for school districts to purchase silent panic alert technology (grant application closes December 12);
- \$10 million for costs related to rapid response training by the Advanced Law Enforcement Rapid Response Training (ALERRT) Center; and
- \$7 million to the Texas School Safety Center



School Safety

In late October, state leaders announced a transfer of more than **\$874.6 million** to support critical public safety and recovery initiatives. Some of the major items include:

- \$400 million to assist school districts in replacing or upgrading doors, windows, fencing, communications, and other safety measures
- \$15 million to assist in the construction of a new elementary school in Uvalde;
- \$339 million to the Texas Military Department for continued border security activities related to Operation Lone Star;
- \$20.6 million to support other state agencies under Operation Lone Star to continue responding to the border; and
- **\$100 million** to the TDEM for COVID-19 response expenses.

Bond Election Results

76 percent of technology related bonds were approved by voters.



Bond Elections

- 62 percent of safety and security bond proposals passed.
- 38 percent of bonds for athletic facilities improvements and athletic centers. About half of stadium proposal were approved.

Taxes

Property Tax Compression

- School district property values grew by a staggering 17% in tax year 2022.
 - Almost 4x the comptroller-estimated growth rate (4.4%)/
 - Almost 2x average growth over last 10 years (8.9%).
- This growth came even with the implementation of Prop. 2, which took value off the rolls with the increased HS exemption.
- Comptroller is estimating property value growth of 3.82% in 2023 and 4.56% in 2024.

Property Tax Compression

- Lt. Gov. Patrick has committed to "an additional \$4 billion for property tax relief."
- Gov. Abbott promised to spend half of the state's surplus on property tax relief during recent gubernatorial debate.
