

**LOS ALAMITOS UNIFIED SCHOOL DISTRICT  
APPLICATION FOR INDEPENDENT CITIZENS' BOND OVERSIGHT COMMITTEE**

The Board of Education of the Los Alamitos Unified School District is seeking qualified, interested individuals to serve on a committee of community leaders which will serve as the Independent Citizens' Bond Oversight Committee ("COC") for the implementation of the District's Measure K and Measure G school facilities bond program.

**Proposition 39 Bond Election**

On November 4, 2008, voters residing within the Los Alamitos Unified School District School Facilities Improvement District No. 1 passed Measure K. Measure K was a \$126,000,000 bond measure that authorizes funding for needed repairs, upgrades, and new construction projects to the District's schools.

On November 6, 2018, voters residing within the Los Alamitos Unified School District School Facilities Improvement District No. 1 passed Measure G. Measure G is a \$97,000,000 bond measure that authorizes funding for needed repairs, upgrades, and new construction projects to the District's schools.

**Establishment of a Citizens' Oversight Committee**

After a bond authorized under Proposition 39 is passed, State law requires that the Los Alamitos Unified School District Board appoint an Independent Citizens' Bond Oversight Committee to work with the District.

**Committee Responsibilities**

In accordance with Education Code Section 15278(b), the Citizens' Bond Oversight Committee shall:

- Inform the public concerning the District's expenditure of Measure K and Measure G bond proceeds;
- Review expenditure reports produced by the District to ensure that Measure K and Measure G bond proceeds were expended only for the purposes set forth in Measures K and G, respectively; and
- Present to the Board in public session, an annual written report outlining their activities and conclusions regarding the expenditure of Measure K and Measure G bond proceeds.

The Bylaws which govern the Independent Citizens' Bond Oversight Committee are attached to this Application.

**Appointment of Committee Members**

All appointments will be made by the Board from applications submitted to the District.

**Time Commitment and Term**

Appointees will serve a two-year term and will be eligible for reappointment by the Board for a second and third two-year term.
