30 Year Timeline:

In 2025, the middle school will be fully funded, the voter-approved capital levy will end, and a new bond will be proposed in its place. This bond will help us further our commitment to keeping tax rates low. The district's goal is to provide a 30-year capital improvement plan that updates our schools to current safety standards. The timeline below outlines our 30-year plan and the schools needing the most attention for safety enhancements.

One of the most significant differences between a levy and a bond is that a bond avoids the need to wait for tax dollars to come in from the community before construction can start. If the 2025 bond passes, our community could have three newly renovated or rebuilt schools by 2028!

What is the condition of the Port Angeles Schools?

Our maintenance crew does an incredible job maintaining our current facilities. However, you can only repair your old furnace, car, or washing machine for so long before it just needs to be replaced. Some of our oldest schools are well past their building lifespan, even with diligent upkeep and maintenance. In 2008, BLRB Architects scored the top five schools with deteriorating building conditions in our district. They looked at HVAC and safety systems and the exterior walls, foundations, roofs, windows, and doors at each school. They scored the buildings from 1-100. Most buildings, on average, lose about 1 point per year for scoring. Buildings rated between 61 and 30 are poor, and those below 30 are unsatisfactory. The projected building scores in 2025 are: Franklin= 20, Stevens = 26, Hamilton = 28, PAHS = 34, and Roosevelt = 52.

- 3) Build a high-quality athletic field at the former site of Monroe Elementary School. (in progress)
- 4) Remodel/expand Stevens Middle School. (in progress)

Capital Levy Progress Update

Monroe Field



High-performance athletic fields are a part of the necessary infrastructure in a high-quality district like Port Angeles. The district is currently building a multi-use synthetic turf field on Monroe Road. Some of the funding for the athletic field will come from the capital levy, but most of the financing will come from the sale of the district's old Central Services Building and savings from the safety vestibule project.

Northwest-based landscape architecture firm, Site Workshop, helped the district design the field and will oversee the construction. The anticipated completion date for the field is in the fall of 2023.

Stevens Middle School

The visioning for the expansion and renovation of Stevens Middle School is underway! This project will address the outdated and aging buildings, allowing for improved learning opportunities. Construction cannot begin until the district collects all tax funds from the capital levy in 2025. The timeline for completion at Stevens is summer 2028.

The program can provide funds to qualifying districts to help defray the cost of building school facilities. SCAP funding is not quaranteed, but it has been available most years. It typically funds a small percentage of the total project cost.
