

**Nu le pa/Chungkhar Cawnpiaknak le Adang Program Hna ah Telnak**

St. Joseph Sianginn Peng (district) Fimcawnnak Board (Board of Education) nih siangngakchia hna nih fim cawnnak ah an hluhchuah khawhnak hnga nu le pa/chungkhar hna nih telpi hi a biapi tuk tiah kan zumh. Siangngakchia a fimcawnnak kongah sianginn a kai chung vialte peng, nu le pa, chungkhar hna le khuami poah (community) kan dihlak in tuanvo kan ngei cio tiah Board nih a zumh. Peng nih fimcawnnak lung a thawhtermi pawngkam a ser hrim lai i, cun nu le pa/chungkhar nih biatak thlakin telpinak kha a biapituk tiah Board nih a zumh. Nu le pa/Chungkhar nih fimcawnnak ah itelnak ah fimcawnnak vuanci zung (department of Elementary and Secondary Education – DESE), peng, nu le pa hna/chungkhar hna le khuami dihlak in tanrualtinak kha a herh tukmi a si.

**Nu le pa/Chungkhar Telnak Tinhmi le Timhnak**

Fimcawnnak Board nih nu le pa/chungkhar telnak ah dawntu thil hna hloh in, cuticun nu le pa, chungkhar hna le khuami dang hna he tanrualtinak thazang petu a si lai ti kan hngalh. Cucaah peng nih nu le pa/chungkhar itel khawhnak lam a ser lai cu sermi lam (plan) a tanglei tinhnak (6) aitemi hna cu a tuan chuah lai:

1. Caan hman, lam hnih, sullam ngeihmi sianginn le inn kar chawnhbiaknak tuah le tha pek.
2. Nu le pa sinak/tuanvo tlinhmi nu le sinak tha pek le bawmh.
3. Nu le pa/chungkhar nih an fa le fimcawnnak ah a biapi tukmi dirhmun ah an sinak kha hngalh le cohlan.
4. Nu le pa hna/chungkhar hna nih an fa le an kainak sianginn ah len duhnak le sianginn program hna an tanpi khawhnak hnga a himbawmmi le ai awngmi (open) pawngkam sinak hna tha pek.
5. Nu le pa hna kha an fa le hna le chungkhar hna he pehtlainak a ngeimi biachahnak tuahnak poah ah telh hna zungzal.
6. Thazang le ngeihchiah chawva hman awk a thami poah sianginn program hna, chungkhar nunning (practices) le siangngakchia hluhchuahnak ah hman.

Hi tinhnak hna cu peng nih hitihin tlamtlinh ai timh:

1. Nu le pa hna nih an fa le hna thinlung taksa an thanchonak ah an cawnpiak hruai hna nakah aherhmi theihhngalhnak an ngeihnak hna cawlcangnak tuah. Mah ahhin peng, buu hna (agencies) or sianginn/community buu hna ( nu le pa-saya te buu hna, Head Starts, nu le pa nih saya bantukin cawnpiak tbk) nih fimcawnnak caantha ser, nu le pa nih fa le cawnpiak hruai thiamnak, fa/leirawl hna thanchonak ah aherhmi hngalhnak (information) pek,

2. Fimcawnnak lei kongah nu le pa chungkhar hna telnak tlamtlin khawhnak hnga caah a tanglei thil tuahning (strategies) hna tel in, including:
  - > Tel khawhnak caantha ummi hna kha nu le pa hna/chungkhar hna hngalhter lengmang hna le program phun phun ah itel awk ah forhfialnak tuah.
  - > Nu le pa hna/chungkhar hna nih an fa le hna he hmanti khawh dingmi fimcawnnak thilri (resources) le lam pek chimh hna.
  - > Nu le pa hna/chungkhar hna kha peng nih fimcawnnak konglei aitinhami hna hngalhter zungzal le an fa le hna hi program hna ah an itelnak hnga le thanchonak an hmuhnak hnga.
3. Chungkhar hna kha an fa le hna fimcawnnak ah lam/phun tapi in telter khawh hna. Tahchunnak, nu le pa hna/chungkhar hna kha peng policies ah an ruahnak chuahter ve hna le sianginn program hna le sianginn khan chungah thazang chuahnak caantha pek hna.
4. Cachimtu (saya) hna le zung riantuantu hna nih thiltuahning (strategies) ah nu le pa hna/chungkhar hna telnak hmual ngei tein an hman thiamnak hna theihhngalhnak cawnpiaknak pek hna.
5. Nu le pa/chungkhar telnak kha sianginn kip le peng ah zohthatnak caan hman tein tuah.
6. Fimcawnnak cawnmi cauk (curriculum) ah aitelmi cawnnak thilri hna halnak a um ahcun hman khawhnak nawl pek/lam ser piak.
7. Tuah awk a that ahcun nu le pa hna nih an theih khawhmi holh in information kha pek.

**Title I, Mipem Fimcawnnak (MEP) le Mirang Tlawmte Thiammi Programs Board nih Title I, MEP le LEP program hna an hluchuahnak hnga nu le pa hna/chungkhar hna telnak a hleiin a biapit tukmi zong a hngalh. Federal phungam bantukin, peng le nu le pa hna nih hi program vialte ah santlai dingmi nu le pa telnak policy kha an tlungtlinnak bantukin suaitinak le tialtinak an tuah lai.**

#### **Title I Nu le pa Telnak Program**

Peng le Title I program ah aitelmi ngakchia hna nu le pa hna nih zeitindah peng nih a tuah lai timi telnak policy an tial ti lai:

1. Title I program plan suainak ah telnak le plan tlamtlinhnak plan le tha deuh tuahnak (improvement) kongah ruahnak peknak.
2. Aitelmi sianginn hna hmual ngeimi simanking suainak le tlamtlinnak ah tuantinak, thil tuahning (technical assistance) kongah bawmhna le a dang a herhmi bawmhna hna kha sianghngakchia hna hluchuahnak le sianginn cawlcangnak

thatnak (performance) pek.

3. A thawngmi nu le pa telnak caah sianginn le nu le pa thazang ser.
4. Title I nu le pa telnak tuahning (strategies) hna kha fimcawnnak program dang hna tuai/kawmh chih in tuan.
5. Nu le pa telnak policy hna nih a caah tuahmi sianginn caah zeitlukin dah hlawknak a chuahpi timi le policy chungtel bia hna kha nu le pa tel in zoh thannak le tha deuhin remhchapnak tuah hna tuah. Mah ahhin upadi nih nawlpeknak bantu kin nu le pa telnak ah dontu thil hna, a hleiin sifak deuhmi nu le pa hna, mi tlamtling lo hna (disabilities), Mirang ca holh tlawmte lawng thiammi, ca thiam tukmi lo hna, or miphun or minung zat tlawm (minorities) kong hna zohnak aitel lai. Peng (district) nih hi zohthatnak (evaluation) ah hmuhmi hna cu hmual a ngeih deuh chin chinmi tuahning (strategies) sernak, remhna k, a herh ahcun, nu le pa telnak policy hna suaisernak ah a hman lai.
6. Nu le pa hna sianginn cawlcanghna k ah biatak chuahin telter.

Title I caah pekmi tangka bawmhna k (fund) hmumi sianginn poah nih Title I program ah aitelmi hngakchia hna nu le pa hna he lungtlinak bantu kin nu le pa telnak policy hna cu federal upadi nih tuah ding a ti bantu kin an sersuai ti lai:

1. Policy cu khua/sangmi (community) hna rel zoh khawh awkin chia h hrim ding a si lai i, sianginn le nu le pa hna herhna k he aitlak bantu kin tharchuah (update) lengmang a si lai.
2. Nu le pa hna, sianginn riantuantu dihlak le sianghngakchia hna nih sianghngakchia fimcawnnak ah hluhchuahna k tuanvo ngeih cionak le zeitindah sianginn le nu le pa hna nih ngakchia bawmh khawhna k caah kan tuanti lai timi hna kha policy chungah aitel hrim hrim lai.
3. Title I program ah aitelmi sianginn poah nih nu le pa hna Title I kong chimhna k caah le sianginn ah nu le pa hna telnak policy hna suainak, zohthannak le remhchapna k hna telin kum dih meeting an auh lai.

### **Mipem Fimcawnnak Program ah Nu le pa Telnak**

Mipem fimcawnnak (MEP) ah aitelmi sianghngakchia hna nu le pa hna cu Mipem Fimcawnnak Program sernak (development), tlamtlinhna k, hmanna k le zohthannak ah telnak le an ruahna k hal le lakna k tuah lengmang a si lai.

MEP sianghngakchia nu le pa hna an fa le hna fimcawnnak ah an hluhchuah khawhna k an tuah/tel khawhna k lam kha hrinfia h lengmang an si lai.

### **Mirang Caholh Tlawmte Thiam (LEP) Program ah Nu le pa Telnak**

Federal upadi bantuikin, LEP (Limited English Proficiency) sianghnakchia hna nu le pa hna cu an fa kha catang zeizatah chiaa a si le peng LEP program kong ah thawngthan lengmang an si lai.

Program chungtel le program ah itelnak kong ah an covo (right) kong kha nu le pa hna cu hngalhter an si lai.

### **Policy Zohthatnak (Evaluation)**
