The district is in receipt of your November 17, 2022 FOIA request. The following search was run based on your request:

all:("removal" OR "reclassification" OR "reconsideration of instructional and library materials" OR "book challenges" OR "Request for reconsideration of materials" OR "Request for review of building level recommendation")

AND

all:("book" OR "books" OR "ebook" "ebooks" OR "audiobook" OR "audiobooks")

AND

Jan 1 2000 - Nov 17

This search has returned 388,942 emails. In accordance with S.C. Code Ann. 30-4-30(B), the BCSD estimates search, retrieval, and redaction, if necessary, of documents to respond to your request will require 3,889 hours, for an estimated cost of \$174,849 plus 6 cents per copy for a total cost of \$198,186. Costs may increase or decrease. A 25% deposit of the total reasonably anticipated cost is required before work will begin on your request. Please make all checks out to the Beaufort County School District and send to my attention.

As your request is extremely broad, in order to lower the cost you may wish to consider narrowing your request to be more specific to include information about each record sought, such as the date, title or name, author, recipients, and subject matter of the records and resubmit your request.
