<p><b>Act 114 FBI Criminal History Report</b></p> <p><i>(overnight trips or residents of 10 years or less)</i></p> <p><i>(Cost for employees &amp; volunteers)</i></p>	<ol style="list-style-type: none"> <li>1. <b>The applicant MUST register PRIOR to going to the fingerprint site.</b> Registration is completed online or over the phone. Registration is available online 24 hours/day, seven days per week at <a href="https://uenroll.identogo.com/">https://uenroll.identogo.com/</a>. Telephone registration is available at 1-855-845-7434. Make sure you register for the PA Department of Education FBI clearance for <u>employee</u> and the PA Department of Human Services for <u>volunteer</u>.               <ol style="list-style-type: none"> <li>a. <b>Service Code</b> EMPLOYEE/CONTRACTOR: <b>1KG6XN</b></li> <li>b. <b>Service Code</b> VOLUNTEER: <b>1KG6ZJ</b></li> </ol> </li> <li>2. <b>On the day of the scheduled fingerprinting, all applicants must bring:</b> <ol style="list-style-type: none"> <li>a. Selected required identity document</li> <li>b. Registration confirmation</li> <li>c. <p><b>Act 34 Pennsylvania Criminal History Check</b></p> <p><i>(no cost for Volunteers)</i></p>	<p>This is an online procedure. Click on the following link and go to "Submit a New Record Check." Follow the instructions through to the Certification Page. Once the Search results Table appears, click on the control Number. Please be sure to retain the control number for your records. Click on the Certification Page to access your official Clearance and print. The Record Check Details page is only a receipt and not acceptable as a "clearance." You can complete everything online and receive your results immediately. <p><b>Act 151 Pennsylvania Child Abuse History Check</b></p> <p><i>(no cost for Volunteers)</i></p>	<p>This is an online procedure. Once you click on the link you will be directed to the Child Welfare Portal where you must create an account or log in if you already have an account. Note: you will need an email address to create an account. Creating an account and submitting your clearance application online will give you immediate access to your results or the status of your results if your results cannot be processed immediately.
