SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. The Mount Pleasant Central School District held a public forum on June 16, 2021 in our Westlake Library, entitled "ARP Stakeholder Meeting", which was also accessible via Zoom. All members of the school community were invited to participate, submit questions in advance of the forum and provide input in the development of our plan to spend our allocation of ARP funds. Members of our school district administration, board of education, union leadership, parents, community members and faculty either submitted questions in advance of the forum or participated directly in-person to suggest how best the district might go about developing its plan to spend the allocation of ARP funds. We will continue to engage diverse stakeholders by reconvening these meetings no less frequently than every six months for the duration of the ARP ESSER grant period and the availability of funds.

In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.**

One of the COVID-19 mitigation strategies suggested by the CDC is proper air filtration. The school district, in accordance with CDC recommendations, intends to purchase HEPA filtration units, which circulates the air in classrooms on a regular basis. Another mitigation strategy the district intends to follow is the purchase of personal protective equipment (PPE) for our music program, in which students are either singing or playing wind instruments. PPE, including bell covers, blow-hole masks, etc. contribute to minimizing the spread of COVID-19. Further, we have committed to maximizing the ability to have students and faculty go outside throughout the school day. In accordance with CDC guidance, we intend to purchase outdoor classroom furniture (desks, chairs, tents, etc.) to facilitate learning in an outdoor setting.

- 4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.**

The Mount Pleasant Central School District regularly administers both diagnostic and formative assessments to monitor student progress and identify those who may be at-risk, and therefore require additional interventions and supports. As part of our Multi-Tier System of Supports (MTSS) plan, we administer the Aimsweb and MAP assessments during fall, winter and spring benchmarking windows. Further, we believe in the use of multiple measures, and therefore also administer pre-assessments through reading inventories and math assessments. Lastly, our faculty are involved in the creation and administration of student learning objectives (SLOs), which assist them in identifying those students who may be in need of additional interventions and supports. Our faculty are also adept at the creation of formative assessments, which inform them on the readiness levels of their students, including those who may suffer from learning loss in connection with the COVID-19 pandemic.

Continuity of learning is a priority for lost instructional time in the Mount Pleasant Central School District. As part of our approach, we plan to offer opportunities for intervention and support for students who are isolated or quarantined during the school year. This will include both virtual instruction and live streaming to those children who are unable to participate in-person at the elementary and/or secondary levels. In addition, we conducted a successful 'Summer Academy' in the Mount Pleasant Central School District this past summer, which was open to all students, whose parents wished for them to access additional intervention and remediation for lost instructional time during the 2020-2021 school year.

Beyond the interventions and mitigation strategies already mentioned, the Mount Pleasant School District intends to spend the remainder of our ARP allocation as follows:

- Personal protective equipment for students in our music program as PPE;
- HEPA filters for air filtration in classrooms throughout the school district to improve indoor air quality;
- Furniture to support school-based outdoor learning experiences and activities to mitigate the spread of COVID-19.

Students in the Mount Pleasant Central School District, particularly those disproportionately impacted by the COVID-19 pandemic, have been prioritized for academic/social emotional intervention, following lost instructional time. In the event that students with disabilities, English Language Learners, etc. are in isolation or quarantine due to a verified positive case of COVID-19 or having been in close contact with a verified positive case of COVID-19, we intend to provide ongoing, virtual instruction to these students. Working with case managers for our students with IEPs and/or our ELL teachers, we will ensure that we are able to mitigate the impact of an absence from in-person schooling. All students have already been provided with Chromebooks and/or hotspots in the event that internet access is problematic.
