Observed dead roaches along floor of staff lounge 2-004 and excrement along doorframes of entrance doors to seving area. Remove and deep clean/sanitize all areas; monitor and treat areas again if necessary.

CODE REFERENCE: 64E-11.003(5)(f). Effective measures shall be taken to control the presence of pests in the food establishment. Unless otherwise approved, live animals shall not be allowed.

General Comments

Re-inspection scheduled for 12/1/2022 delayed due to sick leave.

Violations 38-1, 48, 49 and 54 have been corrected. Facility has been exterminated and deep cleaned, garbage area has been cleared, and all floor drains have been deep cleaned. Satisfactory result issued; correct remaining violation by the net routine inspection.
