








All 3rd Graders Can Read at Grade Level

2022 Goal:

The proportion of 3rd-grade students who show proficiency on the MCA in reading will increase by 8 percentage points from 64% in 2019 to 72% by 2022.

The proportion of students in each student group which scored below 60% proficiency on the math or reading MCA in 2019 will increase by at least 10 percentage points by 2022.



Each student group with a 4-year graduation rate below 90% will increase by 5 percentage points by 2021.*



- Dedicated support of literacy coach



The percentage of students scoring in the proficient categories on the FastBridge aReading assessment at the end of 3rd grade will increase by 3 percentage points from 77% in 2022 to 80% in 2025.

The percentage of Students of Color scoring in the proficient categories on the FastBridge aReading assessment at the end of grades 2-5 will increase by at least 3 percentage points from 63% in 2022 to 66% by 2025, while maintaining an overall proficiency rate of at least 75%.
