OSAA Athletic and Activity Eligibility Guidelines for Early College Students

In order to maintain Oregon School Activities Association (OSAA) Athletic and Activity participation while participating in Early College High School (ECHS), all students are required to maintain a minimum enrollment of classes at PCC that are equivalent to at least 2.0 high school credits, each term. This is keeping with the Early College requirement of enrollment in 12 to 16 credits in order to maintain full time status.

Students and parents/guardians, please read the information below very carefully. Your signature will indicate an understanding of your responsibility to demonstrate and maintain athletic eligibility to Early College staff, your high school coaches/advisors and athletic directors at your home high school. I agree to:

- Enroll in 12-16 PCC credit hours in order to meet the requirement of an equivalent of 2.00 credits at my comprehensive high school:
 - during the athletic/activity season
 - every term (fall, winter, spring) at PCC
- Participate in grade checks listed as student carried.
- Provide this signed form, documenting my enrollment in 12 PCC credit hours and the minimum H.S. equivalent of 2.00 credits to my high school athletic director's office prior to the start of my sport season. This may be before PCC classes begin fall term.
- Notify the Early College administrator, who will in turn notify my athletic coach/activity advisor and high school athletic director, if at any time during the term, I withdraw from a class or fall below the 2.00 high school enrollment equivalency. I understand that The Early College Program will immediately contact the Athletic Director to inform them of the change of my academic and eligibility status.
- Notify the Early College administration if at any point in the term at PCC I receive a Course Progress Notification (CPN) or verbal notification from my instructors, that I am failing their class. I understand that at that point I will be ineligible to participate and will be withdrawn from my team or activity.

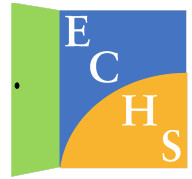

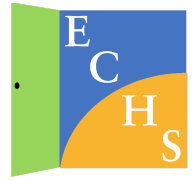
