The Washington County Board of Education met in Regular Session at the Washington County TEL Center at 6:00 p.m. on the 21st day of NOVEMBER 2022 with the following members present:

Board Chair Curtis Hamilton led the pledge of allegiance and Superintendent Dr. J. Robin Cochran read the mission statement.

WCS parent Bridgette Fulkerson spoke to the board, commending the staff of WCES for their work with special needs children.

Staff Recognition

WCS Chief Academic Officer Holly Elmore and Instructional Supervisor Wayne Stevens presented the Stillwell Award to Mike Scyphers, who serves as Director of Technology, Manny Hernandez, who serves as a network technician, and former WCS network technician Grant Landram for their work in providing technology support and assistance during the pandemic.

Legislative Liaison Report

Mr. Thompson reported that the Interim Joint Committee on Education met on October 18, 2022. Items discussed included a presentation on anti-vaping efforts in schools and the Delta 8 and Delta 9 gummies, improving literacy outcomes, the importance of home libraries, and Kentucky revised academic standards for science. The Interim Joint Committee on Education also met on November 1, 2022. Items discussed included a presentation on the Governor's School for the Arts, a presentation on the Governor's Scholar Program, a presentation on CTEs and funding equalization, and a presentation on Kentucky academic standards for social studies.

General Fund:

General fund received \$2,918,714.72 in revenue and spent \$3,144,520.98 in expenditures.

Special Revenue Fund:

Year-to-date expenditures for salaries and fringe are \$822,160.50 and operational expenditures are \$527,176.77.

District Activity Fund:

Year-to-date expenditures are \$37,454.53.

Student Activity Fund:

Year-to-date expenditures are \$32,912.04.

Capital Outlay Fund & Building (FSPK) Fund:

We received \$77,120 in capital outlay funding and \$360,814 in state match FSPK funding. This will be used to offset the debt service.

Construction Fund:

Year to date we spent \$80,705.32 in construction funds.

Debt Service Fund:

Year-to-date principal and interest paid on debt is \$1,017,060.67.

Food Service Fund:

Total year-to-date receipts are \$583,201.15 and expenditures are \$552,275.97.

Day Care Fund:

Total year-to-date receipts are \$57,870.38 and expenditures are \$7,659.70.

Scholarship Fund:

No scholarships have been paid out this fiscal year.

Superintendent's Report

Dr. Cochran reported that the district would be entering into agreements with Campbellsville University for Option 9 programs. She also informed board members that she and chief academic officer Holly Elmore were selected to serve on KDE's Kentucky United We Learn council. She reported that the district had been selected by the Kentucky Department of Education and the Kentucky Council on Postsecondary Education to be a OneGoal inaugural cohort participant. Washington County is one of only 13 districts from across the state selected to participate. She highlighted that each school held Veterans Day celebrations and that the community was appreciative. She highlighted the WCHS Commander Marching Band's recent accomplishment of winning the KMEA State Championship and informed them that the district treated band members and staff to lunch at Mordecai's last week as a reward for their hard work. She also

mentioned that the district was looking into purchasing championship rings for the band members. She informed the board of an upcoming Local Planning Committee (for facilities plan) meeting on November 29.
