## **Florida Christian School Statement of Faith**

As a Christian school committed to faithfully represent Jesus Christ to our students, their families, and the community at large, and to consistently teach scriptural truth in word and example by means of our formal curriculum and informal interactions, whether inside or beyond the classroom, it is required that every faculty member and administrator personally affirm and hold to each of the following statements:

**1. Authority of Scripture (66 books):** The Bible, in its original documents, is the divinely inspired, written record of God's revelation for all people. It is the product of the work of the Holy Spirit through human authors and as such is unique among human literature, without errors in what it teaches, absolute in its authority, and complete in its revelation of God's historical work and means to bring about the salvation of humankind. It is not to be added to nor taken away from as the written word of God.

*Therefore*, I will seek to grow in a correct understanding of the Bible, to believe and act on its promises, to submit to its precepts and demands, and to faithfully communicate its teachings to others. In questions where tradition, culture, scientific positions, or personal preferences conflict with the teachings of Scripture, I will accept the Bible's truth claims as authoritative.

**2. Uniqueness of the Triune God:** There is one and only one true God, without equal nor peer, eternally existent, morally perfect, all-powerful, all-knowing, and present in every place at all times. Although one, He exists as three Persons: Father, Son, and Holy Spirit.

*Therefore*, I will worship God alone and give Him the honor that is due to Him. I will seek to know Him in His three persons, and to relate to Him accordingly.

**3. Mankind as created by God:** The human race was directly and intentionally created by God in His image, and so owes its existence to Him. He is involved in the design of each individual person and has a plan for his or her life.

*Therefore*, I acknowledge that God designed me, that He has complete rights over my life, and that His purposes for me take precedence over my own goals and plans. I am answerable to Him for how I choose to live my life. Moreover, my loyalty to God must take priority over every other loyalty in my life.

**3a. Gender definitions and marriage:** God created humans as male (man) and female (woman). These were designed to complement each other. Neither is intrinsically superior to the other.

While gender roles may legitimately vary somewhat from one family or culture to another, there are essential differences in the two sexes which are not a matter of human choice, and which limit one's options. To reject the gender which one was given at conception is to reject God's design and plan. Marriage is intended to be between a man and a woman. Monogamous heterosexual marriage is the only biblically approved context for the fulfillment of sexual desire; any other outlet is a misuse of one's sexuality.

*Therefore*, I will respect, and honor others of both sexes as created by God. I will accept the gender He has given me and commit myself to express my masculinity or femininity in ways that are pleasing to God and preserve my Christian testimony.

**4. *The effects of sin:*** Each member of the human race is tainted by sin, both by inheritance and inclination and, when the individual reaches an age where they can make conscious choices, by action. Sin is by nature any indifference or rebellion toward the will of our sovereign God or failure as beings created in His image to perfectly represent His character. Sin separates us from a holy God and damages our ability to relate to other people, to the created world, and even to ourselves.

*Therefore*, I will take sin seriously. I will acknowledge my own propensity to sin, will readily confess my sin as I recognize it, will apply myself to avoiding sin and to abandon sinful practices, and will seek to live an upright, God-pleasing life.

**5. *Christ the only and sufficient Savior:*** Jesus Christ, the Son of God and Himself fully God, took on complete humanity and was born into the world as a man. He lived a sinless life and offered Himself as a sacrifice in our place to satisfy God's justice and obtain forgiveness for mankind. He alone is the way God has provided for our sin to be forgiven and for us to be restored into a loving relationship with the Father.

**5a. *Salvation by faith:*** God's offer of forgiveness and restoration is not based on any merit on our part nor by any good works or religious observance but is freely given as a gracious act on His part. A person enters into salvation through faith alone in Jesus Christ as Savior and Lord.

*Therefore*, I will trust Jesus for my own salvation, and will rest with the assurance of the completeness of His work on my behalf which gained my perfect acceptance by the Father. I will recognize the serious condition of those who are without Christ, regardless of how good, religious, or successful they appear, since there is no other way but Jesus to have a true relationship with God.

**6. *Christian identity and personal holiness:*** When a person puts his or her trust in Christ for salvation, God adopts him or her as His child and makes him or her a member of the body of Christ, the church. He also sends His Holy Spirit to indwell the person and give him or her the power to perceive and live out the will of God. His expectation is that His children will live holy lives that reflect His character, as they look forward to the return of Christ and reward for their obedience.



*Therefore, I will choose to live as a child of God and submit my will to the control of His Holy Spirit so as to honor Him in my attitudes and actions. I will seek to relate to others in the body of Christ as fellow members of His family and contribute according to my gifts and abilities to the unity and growth of the body.*

**7. Mission of the believer:** As those called as priests and ambassadors of Christ, it is every Christian's privilege and responsibility to make clear God's plan of salvation wherever and in whatever vocation he or she may be.

*Therefore, I will seek every opportunity to share the gospel in meaningful ways with my family, friends, students, and others that God brings into my sphere of influence, inviting them to trust Christ and enter into the eternal, abundant life that He offers.*

**8. Healing, prosperity, and blessing:** God is all-powerful, loving, and committed to blessing His children. However, although He is fully able to heal, to provide material prosperity and safety, He is under no obligation and does not always choose to do so. His purposes are sometimes hidden from us; but in His unchanging faithfulness He will always act in ways consistent with our ultimate good.

*Therefore, I will trust my heavenly Father in good and bad times, even when I do not understand what He is doing. I will not assume that unanswered prayer or the misfortunes of another believer must be due to sin or a lack of faith. When I invite others into fellowship with my Lord, I will avoid making unrealistic promises of what they may expect from that relationship.*

**9. Temptation and spiritual warfare:** The Christian faces three enemies which seek to draw him or her away from complete devotion to Christ and submission to His will, and so break his or her fellowship with the Lord and render him or her ineffective in accomplishing God's purposes. These are the flesh (the self-serving "old nature" which tries to act independently of God), the world (those systems which surround us and promote values and behaviors contrary to God's character and will) and Satan and his demonic forces. God has given us the means in Christ to be victorious over all three: a new nature made in the image of Christ, the indwelling Holy Spirit, the teaching of His word, and the support of other believers. Although the Christian will ultimately be delivered from all three enemies, in this life he or she is called to actively draw on God's resources to overcome the temptations and deceptions they present.

*Therefore, I will be vigilant in the midst of the ongoing spiritual battle, and will, in constant dependence on the Lord, employ those resources that He provides to resist the temptations that these enemies use against me. I will not allow my sin to remain unconfessed. I will try to learn my areas of vulnerability and seek appropriate ways to deal with them, including asking help of others when I am weak.*

This personal affirmation of faith is based on the official Statement of Faith as set forth in the Articles of Incorporation of Florida Christian School. It is intended to clarify the meaning and practical application of key points in this Statement of Faith and to address important issues not contemplated in the Statement and should not be interpreted to contradict or supersede the same.

If during the course of employment an employee begins to doubt or cannot continue to affirm the above points, he or she is encouraged to discuss their concerns with their FCS direct administrative supervisor. If the disagreement cannot be resolved, the employee will be asked to resign from FCS to protect the integrity of both the school and the employee.
