### **Meetings and Community Access**

Documentation of the process includes meeting minutes, agenda, and sign in sheets. The School Support Team met on May 13, 2024, and again on May 13, 2024, to develop the CNA. The first CNA meeting was held in Teams and started at 3:00pm. The second meeting was held in Teams and started at 3:30pm. We plan to meet again each quarter to review and revise the CNA as needed. If an SST member was not able to attend the meeting, efforts were made to contact the member to update him/her/them on the topics discussed and to gather his/her/ their input.

During the first meeting on May 13, 2024, Principal Adrienne Brown began the meeting with introductions. An ice breaker was conducted to support relationship building. The SST members had a chance to connect and know the role of each team member. Then, Principal Adrienne Brown shared with the group the team expectations. Several handouts were provided to attendees that lead discussions during the meeting. Team members were also given the opportunity to learn about the purpose of the team, learn specific vocabulary like CNA, CIP, Title I. The team also learned about the vision and mission of the YES Prep Hobby Secondary. The importance of attendance and the purpose of this Title 1 Team was emphasized and explained to all members. The purpose of the Comprehensive Needs Assessment was shared. Principal Adrienne Brown then provided each person with a sample list of data options that the committee

members could use to lead conversations to identify which data the committee would review to gather strengths and problems from the 2023-2024 school year. Principal Adrienne Brown lead the discussion as data was identified by the group to be reviewed at the next meeting. The committee decided to look at six specific data points to identify strengths and problems from the 2023-2024 school year. Principal Adrienne Brown thanked everyone for their participation and reminded everyone of the second CNA meeting.

At the second meeting on May 13, 2024, the SST reviewed the listed data and prioritized the information into strengths and problems. The team acknowledged the strengths from 2023-2024 school year but focused on the problems identified in the data. Principal Adrienne Brown led the team in prioritizing the problems. Each team member was asked to help identify three to five focus areas for next year based on the problems identified. The team came to a consensus on three main problems that represent the highest leverage focus areas. These will become the priorities for next year. A Root Cause Analysis was completed on the three problems.

The School Support Team reviewed the data listed to identify strengths and problems.

The process we use to <u>identify</u> students at-risk is:

- Six-weeks documented interventions once a student is in the response to intervention (RTI) process.
- If the student does not improve after six weeks, they will be evaluated by the RTI team to identify other necessary interventions.
- Students would be identified as at-risk after the RTI team meets.

The process we use to <u>exit</u> students from the SCE program who no longer qualify is:

- The RTI team will evaluate at-risk students at the six-week point to determine if they need continued interventions; or
- Based on performance, should be exited from the SCE program.

### Strategies to Serve At-Risk Students

Early Identification: Implement a system for early identification of at-risk students. This might involve reviewing academic performance, attendance records, behavior reports, and input from teachers and counselor.

Small Group Instruction: Offer small group instruction for students who are struggling academically. This allows for more personalized attention and targeted interventions.

Tutoring and Academic Support: Establish tutoring programs or peer tutoring where students can get extra help with challenging subjects.

Data-Driven Decision-Making: Use data to inform decisions and adjust strategies as needed. Regularly analyze academic and behavioral data to track progress and make improvements.

#### Goal #1: STUDENT ACHIEVEMENT

Goal

Hobby Secondary will achieve a 43% on Domain I (the average of 'Approaches' and above, 'Meets' and above, and 'Masters') on the STAAR test, AND meet 100% of STAAR Domain III Targets.

### What are one or two areas of STRENGTH for your campus in terms of this goal?

Middle School Math and ELA courses grew for student achievement and student growth. High School English continues to be a bright spot. TELPAS overall growth improved by double digits.

# What are one or two NEEDS or CHALLENGES for your campus in terms of this goal?

Algebra I, Science, and Social Studies have not grown or have only grown by single digits. Special Education support in classes and appropriate scaffolds and supports for Beginning and Intermediate EB students.

### What will your READING STRATEGY be for your campus in terms of this goal?

We will utilize Reading Intervention and Having a Literacy Specialist to ensure all 6th and 7th graders who have reading gaps are identified quickly and provided appropriate, rigorous support. All ELA classes will have regular Professional Learning Communities that model and practice students doing the heavy lifting and reading independently as often as possible.

# What will your WRITING STRATEGY be for your campus in terms of this goal?

Ensuring that teachers provide ample, rigorous opportunities for students to engage in writing in <u>all</u> courses, including electives. Coaching teachers on "right is right" to ensure that students are doing the heavy lifting when writing and utilizing classroom routines and writing strategies to write grade-level appropriate responses.

## What will your MATH STRATEGY be for your campus in terms of this goal?

Clear academic routines, including calculator usage and scratch paper strategies, that set students up to be able to effectively and joyfully engage in productive struggle. Clear, concise Criteria for Success as guides, not crutches, for our students in all Math classes.

### What strategies will be used to serve AT RISK STUDENTS in terms of this goal?

MTSS, regularly adjusted tutorial rosters, after school tutorials, and small groups.

### What strategies will be used to serve ALL STUDENTS in terms of this goal?

Targeted tutorials, small groups, Reading Intervention, Academic Monitoring, and data-responsive practices that enable to teachers to respond quickly and effectively to gaps in understanding.

# What strategies or programs will be implemented to ensure students are receiving a WELL-ROUNDED EDUCATION?

Coaching will prioritize ALL courses, not just STAAR-tested courses, including electives, interventions, and non-STAAR or non-AP courses. Teachers in all courses will be prioritized in a way that pushes the rigor, joy, and purposeful practice that is aligned to a college-readiness path.
