



Los Alamitos Unified School District FIRST INTERIM REPORT 2022-23

Interim reports are mandated to validate a school district's financial solvency by examining and reporting actual revenues received and funds expended at two specific points during the fiscal year and by projecting fiscal activity through the end of the current fiscal year and two subsequent years. This First Interim Report looks at actual revenues received and funds expended from July 1 through October 31, 2022.

Based upon projections for the current and subsequent two fiscal years and using the assumptions presented below, the District is able to certify it will meet its financial obligations for the current and subsequent two fiscal years.

State Budget Overview

The 2022-23 State Budget was signed by Governor Newsom on June 27, 2022. On August 26, 2022, the Governor signed the Education Omnibus Trailer Bill (SB 185), which made changes to the June 27, 2022 State adopted budget. The budget maintained several proposals that were included in the May Revision; however, many changes have been incorporated in the final state budget. The initial state budget base grant increased to 6.70% from the originally established 6.28%. The LCFF calculation was amended to allow school districts to utilize the greater of current year, prior year, or the average of the most recent three prior years' average daily attendance.

The major K-12 funding provisions included in the 2022-23 state budget:

- \$7.9 billion to establish the Learning Recovery Emergency Block Grant.
- \$3.6 billion to establish the Arts, Music, and Instructional Materials Discretionary Block Grant.
- Full funding of \$4 billion for the Expanded Learning Opportunities Program with changes to calculation of funds, offering, and access requirements.
- Home-to-school transportation funding equal to 60% of expenditures reported in the prior year, excluding capital outlay and nonagency expenditures, and reduced by the transportation add-on to the LCFF.
- Special education base rate increases to \$820 per ADA.

Review of District's Assumptions of the 2022-23 Budget at First Interim

Revenues:

- The LCFF funding comprises the following assumptions:
 - The Base Grant which is funded by grade span based on the District's current or prior year P2 ADA, whichever is higher. For 2022-23, the funded average base is approximately \$10,770 per ADA and we are anticipating using the three prior year average ADA as we are declining in enrollment.
 - K-3 grade span adjustment of 10.4% on the base grant amount.
 - 9-12 grade span adjustment of 2.6% on the base grant amount.
 - Supplemental Grant equal to 20% of the base grant amount adjusted by the District's percentage of English Learners (EL) and Free and Reduced-Price Meals (FRPM) unduplicated count which is 17.66% for Los Alamitos Unified School District which equals to \$3,392,577.
- The cost of living adjustment (COLA) is projected at 6.28% with a one-time increase to the LCFF base of 6.70%
- Based on enrollment estimates as of October 2022, we are projecting our actual 2022-23 ADA to be 8,509.82, not including County ADA, a decrease of 191.53 ADA over the prior year. However, based on the enacted state budget, funding will be based on the prior three-year average ADA of 9,260.88, not including County ADA.
- Increase in Special Education AB602 funding to the base from \$715 to \$820 per ADA is included at First Interim.
- A one-time Arts, Music & Instructional Materials Block Grant and the Learning Recovery Emergency Block Grant of \$9.5 million is included at First Interim.
- A transitional kindergarten base grant adjustment and add-on of \$2,813 per ADA is included at First Interim.
- Unrestricted lottery income is projected at \$170.00 per annual ADA and restricted lottery income is projected at \$67.00 per annual ADA.
- STRS on behalf contribution state revenue of \$6,354,212 is included at First Interim.

Expenditures:

- Total salaries increase by \$867,553 from Adopted Budget due to additional instructional assistants for the implementation of Universal Transitional Kindergarten and additional custodial staff needs.
- The current cost of salary step and column are included.
- Statutory benefits (Medicare, Social Security, Workers' Compensation, State Unemployment insurance) are adjusted accordingly with increased salary costs. The cost of STRS on behalf contribution of \$6,354,212 is included at First Interim.
- Health and Welfare costs are estimated at \$15,903 per employee for 2022-23 at First Interim which is an increase of \$1,231 per employee from 2021-22.
- Budget for Books and Supplies increased by approximately \$10.3 million due to allocation of discretionary carry over funds and additional one-time funds.
- Budget for Services and Other Operating Expenses increased by approximately \$5.9 million due to allocation of discretionary, restricted carry over funds, and allocations of one-time funds.
- Budget for Capital Outlay increased by \$987,000 to replace diesel school buses using grant funds and carry over technology funds.

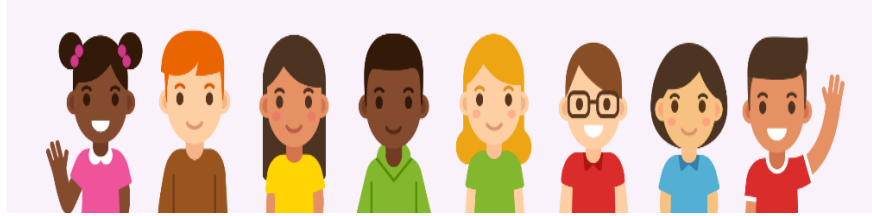
