### Highlights of the Proposed Budget

- More high level science opportunities
- Support for the district's 21st Century learning initiatives
- Facilities upgrades to enhance the learning environment
- New science, technology, engineering, mathematics (STEM) and enrichment opportunities

- Retention of small class sizes and student/teacher ratios

### **Efficiency and Long-Range Planning Shape Budget**

ach year's budget process is guided by the District's long-range plan and an ongoing commitment to pursue organizational efficiencies and focus on sustainability. This allows us to achieve our primary goal – providing the highest quality educational experiences for all 7,000+ students in the District – while remaining fiscally responsible. The 2018-19 proposed budget totals \$218,593,020.

We identified cost-saving efficiencies and structural changes to allow us to capture future savings, thus adding new and exciting learning opportunities for our children while containing the budget increase to 2.08% over the current year's budget. This will be supported by a tax levy increase that complies with the tax cap and translates to an estimated 2.88% increase in the tax rate.

# **Propositions for Voter Approval**

On May 15th, in addition to the 2018-19 Budget, voters will be asked to approve two propositions:

### • Use of Capital Reserve Funds


This proposition asks for voter approval to use up to \$10,000,000 from the District's Capital Reserve Fund for school improvement projects throughout the district, including: lighting and plumbing improvements, roof repairs, student restroom renovations, ceiling replacements, and more. This will not result in a tax increase and reduces future taxpayer burden by saving an estimated \$2.3 million in serial bond interest and issuance costs.

### • Transportation for Grades 9-12

This proposition asks for voter approval to provide transportation for students in grades 9-12 who live more than one mile




from their school, at no cost to families. Currently, that service is offered for a fee of \$1.75 each way. The cost for the new service is estimated at \$166,000 annually, but the District expects this will be offset by savings from routing efficiencies, based on a reduction in buses needed for regular transportation service, and that *there will be no additional cost to taxpayers*. These changes will also improve safety while maintaining reasonable busloads and ride times.

## Proposed Budget FAQs

Q. Does the White Plains City School District comply with the New York Property Tax Law?

A. YES. The estimated tax levy of \$183,020,060 is compliant with the tax levy cap, as prescribed by law.

Q. Does the tax levy indicate how much my taxes will rise?

A. NO. The tax levy represents the amount of school district funding provided by local property taxes after taking into account other sources of revenue. The estimated tax rate is projected to increase 2.88%.
