Highlights of the Proposed Budget

- Expanded STEM enrichment and elective opportunities in Grades 2 & 3 and at the High School
- Elementary Math specialists to support student progress
- Increased capacity in our Fine Arts program to support student demand for instrumental music lessons
- Reallocation of expenditures to support more in-district programs for special needs students
- Increased support for elementary recess supervision and key curriculumbased field trips
- Strengthening of interscholastic athletics program offerings and safety measures
- Improved security systems and procedures
- Playground improvements, roof replacement work and a new HS intercom system

A Balanced Approach in the Pursuit of Excellence

The history of careful fiscal stewardship that has enabled our school district to maintain a balanced budget has also created the opportunity to focus on providing our students with an even more balanced range of opportunities for the 2017-18 school year. A strategic reallocation of resources allows us to support these expanded opportunities while containing the budget increase to 2.58% over the current year's budget.

This rate of increase is typical for school districts in our region and also is consistent with the rate of inflation in our region. The resulting proposed budget of \$214,135,854 will be supported by a tax levy increase that complies with the tax cap and translates to an estimated 1.75% increase in the tax rate.

The annual school budget in White Plains has traditionally been developed with an eye towards future sustainability and the proposed budget for 2017-18 is no exception. After input was gathered both internally and via a community forum, the resulting recommendations were evaluated based on their compatibility with the District's long-range plan and their impact on the long-term sustainability of that plan. STEM (science, technology, engineering, math) emerged from this process as a particular area of need for greater emphasis and this is reflected in our budget proposal.

While fiscal uncertainties lie ahead for school districts throughout the state, we are confident that the proposed 2017-18 budget sustainably balances our tradition of conservative fiscal management with our ongoing pursuit of excellence in the opportunities we provide to our students.

Ricca Named New Superintendent of Schools

The White Plains Board of Education has announced that Dr. Joseph L. Ricca will become Superintendent of Schools on July 1, 2017. Dr. Ricca was expected to be appointed at the May 8th Board of Education meeting, after this newsletter went to print. He succeeds Dr. Howard W. Smith, current Acting Superintendent.

Rosemarie Eller, Board President, said 66 We believe that Dr. Ricca's experience, record of success and enthusiasm qualify him to provide outstanding leadership for the district.??

Dr. Ricca has eight years' experience as a Superintendent – the last four in the Elmsford Union Free School District and, prior to that, in East Hanover, New Jersey. He also has experience as a teacher and principal. He has a bachelor's degree from Seton Hall University, two master's degrees – from Harvard University and Caldwell College – and an Educational Doctorate from Walden University. He also did advanced studies at Oxford University in England.



Applications were received from 40 candidates in 10 states and after initial interviews with top candidates, the Board narrowed the list and expanded the interview team. It included representatives from staff associations, parents and the community.

To vote in this election, an individual must be a registered voter, a resident of White Plains for 30 days prior to May 16th and at least 18 years of age.

SCHOOL HIGHLIGHTS

Colonial Day at Post Road

The White Plains High School Math Team placed 8th in the Westchester Interscholastic Math League for 2016-2017. Seniors Noah Lichtblau and Rose Gebhardt repeated as All-County Mathletes. Rose placed 30th out of 500 stu-

dents with a score of 24 out of 30 correct answers. Noah was Co-Mathlete of the Year, scoring 29 out of 30.

National Merit Finalists

Congratulations are in order for White Plains High School students Elana Hausknecht, Nicholas Crino and Noah Lichtblau. They are among the 15,000 National Merit Finalists nationwide, selected from 1.5 million entrants. They are now eligible to earn one of the 8,000 National Merit Scholarships.

Nicholas maintains a 5.4 grade point average and attained a nearly perfect score on the ACT. He is an Eagle Scout, a member of the Cross Country Track Team and participates in the Science Research Program.

Elana is a gifted musician, playing the euphonium and trombone. She played in the All-State Wind Ensemble last winter, won a concerto competition with the Yonkers Philharmonic Orchestra and was selected for the 2016 All-National Band.

Noah took three science courses at once his junior year (AP Chemistry, Physics Honors and Science Research) and as a senior worked with our Math Coordinator to take an online course in Multivariable Differential and Integral Calculus through the Stanford Online High School.

Musical" was attended by approximately 650 people and received rave reviews. Director and teacher Jennifer Irlen credits the "outstanding cast and crew" of 48 students for that acclaim.

More than just an honor roll, NJHS serves to honor those students who have demonstrated excellence in the areas of scholarship, service, leadership, character, and citizenship. Proposed Budget FAQs

Q. Does the White Plains City School District comply with the New York Property Tax Law?

A. YES. The estimated tax levy of \$176,898,823 is compliant with the tax levy cap, as prescribed by law.

Q. Does the tax levy indicate how much my taxes will rise?

A. NO. The tax levy represents the amount of school district funding provided by local property taxes after taking into account other sources of revenue. The estimated tax rate is projected to increase 1.75%.

* Statement of assumptions made in projecting a contingency budget for the 2017-18 school year, should the proposed budget be defeated twice, pursuant to Section 2023 of the Education Law: The contingency budget requires that the 2017-18 tax levy be no greater than the previous year's levy. Therefore, budget cuts totaling \$5,923,725 would be required, resulting in significant impact to program offerings. In addition, adjustments for disallowed equipment, capital projects are included. Non-school groups using district facilities would be required to pay the full cost.

** List Separate Propositions that are not included in the Total Budgeted Amount: Tax Levy associated with educational or transportation services propositions are not eligible for exclusion and may affect voter approval requirements.
