We are in receipt of your November 9, 2022 FOIA request. The Beaufort County School District does not do business with El Education or Tarika Sullivan, and as such there are no invoices or contracts for either of these entities.

An email search for El Education and/or Tarika Sullivan resulted in over 1,400 advertising/solicitation related emails. The BCSD estimates retrieval, and redaction, if necessary, of these emails to respond to your request will require approximately 10 hours, for an estimated cost of \$449.60 (plus 6 cents per copy if printed). Costs may increase or decrease. A 25% deposit of the total reasonably anticipated cost is required before work will begin on your request. Please make all checks out to the Beaufort County School District and send to my attention.

In order to lower this cost, you may wish to consider narrowing your request to be more specific to include information such as a further refined date range and resubmit your request.
