Superintendent's Report

Superintendent Cordon reflected on the steady leadership of our Board throughout the pandemic, recalling that as the first 6A school district in Oregon to return secondary students to in-person learning, the Board successfully balanced needs of the Roseburg community with the requirements school districts faced in keeping students, staff and the community safe. Board leadership resulted in year after year of clean public audits, directing the sale of pension obligation bonds expected to save the district \$18 million in PERS obligations over the next 20 years; reviewed and updated district policies; and facilitated adoption of updated health, English and math curriculums that align not only with state standards but with our community's values. The Board's Strategic Plan was adopted and updated, ensuring the work of our district aligns with the goal that "All students will receive the care, support and instruction needed to graduate from high school with plans for their most successful futures." PUBLIC HEARING

A Public Hearing was held to review proposed findings to support an exemption from traditional bidding processes and use of the CM/GC method of procurement for the Eastwood Elementary School seismic rehabilitation. The Board voted unanimously to approve the proposed findings and use the CM/GC method of procurement as proposed for Eastwood School for \$2,497,894 to seismically strengthen the multi-purpose room and a classroom wing area to both life safety and immediate occupancy standards.

Design & Engineering Services **Contract Award for Eastwood** School—RFP 22-722

The Board, acting as the Local Contract Review Board, awarded the proposal and directed the business office to negotiate a contract for \$255,200 with ZCS Engineering and Architecture for engineering services for the Eastwood Elementary School Seismic Rehabilitation Project.

Presentation of the 2021-22 **Audited Financial Statements**

Finance and Operations Director Cheryl Northam introduced Ms. Aria Bettinger, CPA/Partner, and Ben Cohn, CPA/Sr. Manager with accounting firm KDP CPAs LLP. Ms. Bettinger and Mr. Cohn shared required communications to the School Board subsequent to the completion of the 2021-2022 fiscal year audit. Following review of the main focus areas, Ms. Bettinger advised the Board that the audit had been awarded an "unmodified opinion", explaining that this is the highest level of assurance attainable.
