The district is in receipt of your December 8, 2022 FOIA request. Our IT department performed a search of emails to or from Drs. Stratos and/or Rodriguez with the terms book/books for the requested date of October 21, 2022. This search has returned 76 emails.

In accordance with S.C. Code Ann. 30-4-30(B), the BCSD estimates search, retrieval, and redaction, if necessary, of documents to respond to your request will require approximately one hour, for an estimated cost of \$44.96 plus 6 cents per copy for a total cost of \$49.52. Costs may increase or decrease. A 25% deposit of the total reasonably anticipated cost is required before work will begin on your request.
