The district is in receipt of your December 8, 2022 FOIA request. Our IT department performed a search of emails to or from Drs. Stratos and/or Rodriguez with the terms book/books for the requested date of October 20, 2022. This search has returned 75 emails.

In accordance with S.C. Code Ann. 30-4-30(B), the BCSD estimates search, retrieval, and redaction, if necessary, of documents to respond to your request will require approximately one hour, for an estimated cost of \$44.96 plus 6 cents per copy for a total cost of \$49.46. Costs may increase or decrease. A 25% deposit of the total reasonably anticipated cost is required before work will begin on your request. Please make all checks out to the Beaufort County School District and send to my attention.

If you would like our IT department to use different search terms, please send us the specific terms you would like used and resubmit your request. Our IT department is more than willing to run the exact search terms that you request.
