The Town Meeting of the Town of Suffield was called to order by Town Clerk Kathleen Dunai, at 7:02 PM. The Town Meeting was held at the Suffield Middle School, 350 Mountain Road, Suffield, CT.

Upon nomination by Melvin Chafetz, 803 Mapleton Avenue, with a second by Ryan Anderson, 128 Halladay Avenue, Edward McAnaney, 85 Wren Drive, was unanimously elected moderator by voice vote.

There were no additional nominations for moderator from the floor.
















SPAULDING SCHOOL BOILER PROJECT

- Replacement Cost: \$296,000 (\$148,000 each)






McALISTER SCHOOL BOILER PROJECT

 Replacement Cost: \$138,000






MCALISTER CLASSROOM AIR CONDITIONING UNITS

McAlister Intermediate School-Replace six aging mini split AC units with new models.

PROJECT #4

Suffield High School- Replace 17 original rooftop units with new higher efficiency units.

Project Rationale

In 2022, Governor Lamont signed Public Act 22-118, establishing a new grant program that encourages public school districts to install, replace, or upgrade heating, ventilation, or air conditioning (HVAC) systems (OSCG&R 2022). As a result, the State of Connecticut has appropriated \$150,000,000 in grant funding for school districts to upgrade school HVAC system which will significantly offset taxpayer burden on projects that would otherwise be funded through the Town of Suffield's capital project budget.

The four projects we are proposing for state reimbursement have were identified within our capital improvement plan and the Long-range Master Facilities Plan study conducted by Tecton Architects. The capital projects will receive 54% reimbursement from the State of Connecticut
