The Surety Company executing the Bond shall be listed on the Treasury Department's most current list and authorized to transact business in the State of Ohio. Bids of Corporations not chartered in Ohio MUST be accompanied by proper certifications that such Corporation is authorized to do business in Ohio.

Attention of the Bidder is directed to the requirements that each proposal must be accompanied by a Non-Collusion Affidavit, properly executed by the Bidder. Further, the successful Bidder will be required to execute a Delinquent Personal Property Tax Affidavit required by Sec. 5719.042 of the Ohio Revised Code. No payment shall be made on any contract for which no such affidavit has been submitted.
