

A dedicated stormwater page will be established on the District's website. The District will continue to educate and provide outreach to students through We Future Cycle. The District will continue to provide training for students every Fall. The District will continue to educate all elementary school and middle school students in daily waste reduction efforts.

B. Briefly summarize the observations that indicated the overall effectiveness of this Measurable Goal.

The We Future Cycle program was temporarily discontinued at the District due to COVID-19. The District posted educational stormwater and other environmental topics on the District's website and in online newsletters. The District has two active environmental clubs (High School and Middle School) which met weekly via Zoom. The clubs promoted their weekly meetings, guest speakers, and activities via REMIND and provided informational flyers in school buildings. The clubs also advertised on the District website. Topics that have been addressed during school club discussions include the following: green infrastructure, smart growth, sustainability, recycling and reusing, trash management and water conservation.
