Recommended Action	Authorization to Award the Request for Proposal for Investigative Services for the 2022-2023 school year.

**WHEREAS**, the Board of Education of the White Plains City School District on March 25, 2022, publicly advertised and invited sealed proposals for Investigative Services for the 2022-2023 school year. The proposals were required to be received by April 7, 2022;

**AND, WHEREAS**, proposals were evaluated on a weighted system established by the District for each of the categories to be reviewed. The evaluation criteria included special knowledge or expertise of the proposer, suitability for the District's needs, quality of services to be provided, staffing/time available, and fee schedule as reasonably determined by the District;

**AND, WHEREAS**, on April 7, 2022, the White Plains City School District received two (2) proposals for Investigative Services from A.L.K. Investigations, LLC. and MBF Investigative Services who submitted proposals for the services and rates attached;

**THEREFORE, BE IT RESOLVED**, that based on the evaluation criteria established by the District, the Board of Education accepts the proposals and authorizes the Assistant Superintendent for Business to enter into an agreement with A.L.K. Investigations, LLC. and MBF Investigative Services to provide Investigative Services for a contract term of July 1, 2022 - June 30, 2023.
