- To please completely fill out the included enrollment form
  - We encourage you to mirror your license expiration year.
  - Ex. Sub License expires 2025- select the 3 year option for \$30 so you stay on sub list for rest of the cycle.
- Cash or check made payable to the ROE # 35 Licensure
- If there has been a lapse in employment (> 1 year) we will need an updated PHYSICAL, TB test and BACKGROUND CHECK.

We want to be able to have an accurate list of substitutes that are active and would like to be in the classrooms, which we can give out to the schools.

With that information, please also be aware that once we receive the completed form and check, your information will then be added to our LIVE Sub List that all of our schools will have access to! This is an additional service we are providing to both our subs and schools. If you choose to not be on this list it will NOT affect your license or current school relationships.
