Condition: Fair. All laptops power on and have functional keyboards and track pads. All laptops were able to be wiped and have Mojave installed. Laptops may have minor cosmetic damages such as small dings and dents. Some laptops have stickers. All laptops have sticker residue. Not all ports have been tested to verify functionality. Of the 63 laptops posted, 12 have known damages worth mentioning:

- Two laptops are missing the "Up" key
- One laptop is missing the "Esc" key
- One laptop is missing the "F" key
- Two laptops have stiff click pads
- Two laptops have slight screen discoloration
- Two laptops are missing screws on the bottom cover
- One laptop does not receive charge but functions correctly when plugged in
- One laptop has sharpie, moderate dents, missing screws, and a shattered click pad that still functions
