


Why should you learn anything about Social Media when you don't want to use Social Networking?

## Maintain Your Privacy

 Always set privacy controls and filters when you set up your profile.



- Check privacy settings monthly Media Services will change them periodically.
- Avoid giving out personal information
  - Address
  - Phone Number

### Personal vs Professional



- They will find out...Don't write anything you don't want your mother, minister, co-worker or boss to read.
- If you don't, who will...Promote yourself or your personal causes w/in reason.
- For every action, there is an equal and opposite reaction...There is a protocol to follow for concerns related to work and it does NOT involve airing your frustrations in a public forum. ...one-on-one conference, formal complaint, grievance....etc. Don't post negative comments about students, parents, your work environment, the school, the school system, the other school employees,....etc.
- The brick wall syndrome...Don't get into arguments....you can't win through short messages.

### **Posting Pictures**

 DO NOT Use social media to post pictures of students. Before the school system can post anything, even a picture of a student, the parents must sign a release.







Well I have an annual IEP this morning with lawyers and crazy parents. The student is a hot mess but so sweet! So after work I'm hitting happy hour at least I have something to look forward too!!!! Deep breath.....I'm going in!

The meeting began at 9 a.m. By 9:15 a.m., parents of another child in the class had screen-grabbed the post and emailed it to Jacqueline Williams, the district's director of special education. By the time the meeting ended at 10:30 a.m., an attorney who represents the school district had seen the email and forwarded it to human resources, according to one of the parents who'd been monitoring the teacher's posts. The next morning, Hutton was removed from the classroom.

Akron, Ohio middle school math teacher Melissa Cairns could see her career come to a grinding halt next Monday when the Akron Public Schools Board of Education meets to decide whether to fire her over a controversial photo posted to her Facebook.



The 33-year-old seventh and eighth grade teacher at Buchtel Community Learning Center was placed on paid leave Oct. 19 upon discovery of a Facebook photo depicting eight or nine of Cairns' 16 students with duct tape over their mouths and a caption reading, "Finally found a way to get them to be quiet!!!" Cairns has been teaching in the district since 2007, the Akron Beacon Journal reports.

Cairns told WEWS the post was meant to be a joke, but she regrets posting it to Facebook. One student was using the duct tape to fix a binder and jokingly placed a piece over her own mouth. The student's peers quickly joined in, and the class encouraged Cairns to take a photo. The image has since been removed from Facebook.



## Same Song—2<sup>nd</sup> Verse

<u>**Do not**</u> "friend" students on your personal social media sites, create a "professional" venue if you want to communicate with your students in this way.

**Do not** post on social media during the day from your cell phone – not even at lunch or on breaks.

<u>**Do not**</u> allow inappropriate content (pictures, postings, etc.) to be posted on your Facebook wall.

<u>Do not</u> post anything on social media you wouldn't want your mother to see. If you wouldn't want your mother to see it – then you don't want your boss to see it.

<u>**Do not**</u> neglect your privacy settings. Check every few weeks to make sure nothing has changed.





## Don'ts of Social Media

<u>Do not</u> post nasty, ugly, or unprofessional comments about the school, the system, any employees, students, etc. on social media. They will find out.

**Do not** forget that school systems and companies are now reviewing social networking sites as part of the hiring process.

**Do not** forget to log out...ever!

**Beware** of games and applications!

## You should know...

### Postings can be screen captured and saved as a pdf.

Just because you aren't on Social Media, doesn't mean you aren't ON Social Media. Google your name once a month.

Problems will arise at school between students surrounding something someone put on Social Media... be prepared. Have a policy about cyber-bullying in



## Your duty to students...

• **Safety first...**it is your responsibility to provide a safe learning environment for student learning. Anticipate risks and then take precautions accordingly. Train students on proper use of equipment...practice safety routines/procedures; students should never be unattended



• **Be prepared....** Well organized and planned activities will prevent many discipline problems. Plan extra; students learn at different paces and "idle hands" result in discipline issues. <u>Use praise/reward to reinforce desired behavior</u>; Vary pace & technique and make your *physical presence* known....walk amongst the students—if you are stationery, be at the back of the students; can't tell what area is specifically monitored; call on every student to ensure participation/attention. If possible, review the assignment at beginning and end of each class to reinforce retention.



If you CANNOT be on Time,

### Be on time....



if you are late, someone else is having to do double duty to cover...or worse, students may be unattended and this results in

liability issues.

## **Set the Example...**model behavior you expect from students.

- It's all about respect....Address students in a manner with which you expect to be addressed. Respect personal space and maintain those boundaries with your own personal affects (desk, purse, computer, etc.) Modulate tone and maintain control of a situation...Encourage student's to question re. assignment but not your authority as that day's instructor in the classroom.
- You can be friendly, caring, helpful, compassionate...but YOU
   CANNOT BE a STUDENT'S FRIEND....refer sensitive
   situations/student's to the appropriate administrator...this might also apply to parents.
   Friends expect you to "act" like their friend...they expect special treatment in certain circumstances.



## Role Models...

Attire...Appearance matters

(if it looks like a duck; first impressions will be that it also quacks.)

- Dress professionally for your subject
- Do not wear revealing attire (crevices should be seen in rocks not on those who serve public education. It's called underwear for a reason...it should not be visible.)
- Jeans (casual) should be worn on Friday unless you have special permission
- T-shirts are not professional attire
- Old Navy flip-flops are not professional attire.
- Shorts should be limited to gym or Field Day




### Role Models...

- Do not curse in front of students
- Monitor students in and out of the classroom
- Prepare for emergencies...BoE protocol & drills; permission slips/documents, special conditions/medical restrictions; emergency kits/equipment/procedure; be familiar with classroom drills....(student altercations; medical emergencies; etc)
- If you can't say something nice....avoid being critical of students & all associated with your profession
- Follow directions
  - Read the daily/weekly messages
  - Follow the lesson plans; note any discrepancies...
     ex: Johnny B. need more time for the assignment
  - Attend school system trainings/meetings



## **FERPA**



- Provides privacy protection for students
- Applies to schools receiving federal funding
- Allows rights for students to view files and protects files from being viewed by a third party
- Use common sense with student information

### Common Sense Suggestions (FERPA style...)

- Do not disclose personal information about students
- Protect information in your possession (grades, records, logs). Be sure they're kept in a secure location.
- Protect employee information
- Do not disclose students' personal lives with others...community members (divorce, custody, etc.)

### A Few Reminders...

 Do not bring medications into your classroom or worksite. If necessary, store them securely in the nurse's office or locked location.

School Time = School Business
 Personal Time = Personal Business
 Attend to personal matters on your time.
 This includes personal cell phone calls.

Get permission or notify your supervisor/administrator if there is a situation in which the cell phone is needed during the work day.

 Remember that students now have cell phones- with video capabilities. You do not want to be a YouTube sensation.
