### **School Responsibilities**

#### MAS will:

1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards as follows:

The school follows a district-wide curriculum that is fully aligned with the NYS common core learning standards. Curricular revisions and refinements take place each summer.
