2. Prices must be stated in units of quantity as specified.
3. All prices must include transportation and delivery to the warehouse or school specified.
4. The Board of Education reserves the right to waive defects and informalities in proposals, to reject any or all proposals, or to accept any proposals as may be deemed to its interest.
5. It is the responsibility of the bidder to provide content data, as required by law (SDS) when applicable, stating that the item meets federal, state and local regulations.
6. When applicable, the bidding vendor awarded must have a representative available for on-site visits if a special need arises or if there are any problems with the item bid.
7. Federal Excise Taxes or Kentucky Sales and Use Taxes are not applicable to any purchase made for use of the Pulaski County School District. Bids should not include any such taxes.
8. Bids will be awarded based on what we evaluate to be the "best value" for our District. Best value is determined by cost, quality, customer service, past experience, etc.
