The SHAC meeting was called to order at 1:30pm by Dr. Lori Nunez. She welcomed all in attendance and discussed the agenda for the SHAC meeting.

The meeting minutes from May 17, 2022, were reviewed and approved.

Dr. Nunez introduced new SHAC Committee members and went over SHAC Roles and Responsibilities. She reviewed the AISD SHAC mission, Vision and 2022-2023 SHAC Goals.

Nutrition Service: Dr. Nunez introduced Abigail Trevino, new AISD's Child Nutrition Director. Ms. Trevino explained to SHAC that the COVID-19 Relief Meal Program expired at the end of last school year. Families are expected to apply for food services if benefits are to continue for the 2022-2023 school year. Ms. Trevino encouraged campuses to have child nutrition paperwork, including applications, accessible for families as needed. Ms. Trevino shared information on the "National Lunch Week", October 11 - 14. Each campus will invite family members for lunch. Campus will have incentives each day for purchasing a meal.

Parent/Community Involvement: Dr. Nunez shared how successful the "Back-to-School Bash" was for the district and community. She has SHAC to work in groups, discussing "pluses" and "deltas" pertaining to the Bash. Members were to write groups' discussion points on Post-its. When time was called, one member from each group shared out the positive and negative Post-its.

Drug Testing Program: Dr. Nunez shared information, process, and completion of the revised Drug Testing Program, as SHAC had voted last year. She had the revised Handbook for SHAC members to review. Dr. Nunez also stated that the document was updated on the AISD's Website under Healthcare.

Health Services: Nurse Davis, district RN, gave an overview of the AISD District Health Clinic and what was trending medically. She stated that strep throat was the most common cause of visits to this point in the school year. Nurse Davis explained that scholars are now required to have a physical prior to their selected sport each year. *Goodside Health* assisted the district in May with over half of the scholars' physicals at the High School. This was a huge benefit to our families. Nurse Davis gave an update on the SHAC's selected Abstinence program. She stated that implementation occurred in May for the school year 2021-2022. Science teachers at the Junior High and High School would be trained prior to the implementation of this school year's instruction. The Abstinence Program will be an "Opt-In" process this school year. Lastly, Nurse Davis explained that the new protocols for Covid-19 require students and teachers to quarantine for 5 days only. After those 5 days, masks are highly suggested for five days, equally the once required 10 days.

Counseling, Psychological, & Social Services: Dr. Nunez shared with SHAC that Counseling, Psychological & Social services are being added to each SHAC agenda. The *Be Kind*, social emotional learning, program by Ms. Jessica has been extended to all three elementary schools this year. She is providing a weekly, 30 minute, lesson via Zoom, grades Pre-K through 2nd. A program called, Rachel's Challenge, is being offered for social emotional learning in grades 3rd through 8th. Rachel's Challenge will be presented on Tuesday, September 27 to the students during the school day and to the parents, community members, and business that evening at the Junior High School. The Intermediate and Junior High School will have teacher and student ambassadors to continue the work of the challenge after the presentation. This will be a year-long list of events.

Physical Education: Dr. Nunez explained to SHAC that TEA did not offer much for the elementary campuses to select from for Proclamation 2021. Due to the lack of resources, AISD decided to continue with the CATCH K-8 Physical Education as the state adopted curriculum. The district purchased a one-year digital textbook for teachers to use as a resource in their physical education classrooms. The district can reevaluate after this school year to decide whether they will continue with CATCH.

Speaker: Mrs. Emma Latimore, Texas Department of Health, spoke to SHAC pertaining to Suicide Prevention and how the Texas Department of Health could be of service or used as a resource.

All SHAC members were thanked for coming to the meeting and participating. The next SHAC meeting is scheduled for Tuesday, November 15, 2022 at 1:30pm in the AISD Boardroom.
