

**NYS Teacher Centers Policy Board Composition 2022-2023 SECTION 5**

Teacher Centers shall abide by the Policy Board composition required by Education Law 316 as well as the membership requirements in the centers by-laws. Compliance is required for funding approval.

- The Teacher Center Director is hired by and reports to the Policy Board. They are expected to attend all meetings but are not members of the Policy Board. Do not include them on this list.
- Do not identify any positions as "not yet filled", "vacant", "TBD", "alternate" or "non-voting" (all members of the PB are voting members).
- One individual member may fulfill only 1 role. (example: a teacher designed by the bargaining agent may not also fill the requirement of a parent member).
