

MEDFORD BOARD OF HEALTH

Regulation 4: Minimum Standards for Recreational Camps for Children
105 CMR 430.000 Minimum Standards for Recreational Camps for Children: State Sanitary Code Chapter IV

A. Purpose

The purpose of this regulation is to legally empower the Medford Board of Health to enforce requirements including and in addition to existing State and Federal laws and regulations for recreational camps for children. The adoption of these regulations and laws by the Medford Board of Health is an effort to protect the health and safety of the Medford community.

B. Adoption of the Minimum Standards for Recreational Camps for Children 105 CMR 430.000 Minimum Standards for Recreational Camps for Children :State Sanitary Code Chapter IV

105 CMR 400.000 State Sanitary Code I General Administrative Procedures and 105 CMR 430.000 Minimum Standards for Recreational Camps for Children: State Sanitary Code Chapter IV is hereby adopted as most recently amended, and with automatic adoption of future amendments and changes at the state and federal level as a local Medford Board of Health regulation. The following additions are included:

430.750 Operation without a License

Whoever operates a recreational camp for children without a license shall upon conviction be fined not less than ten, nor more than one hundred dollars in accordance with M.G.L.c. 140, s. 32E. This may be enforced by the Medford Board of Health once all necessary notifications and procedures are followed. A person shall be subject to a fine of fifty dollars (\$50.00). Each day that the offense continues shall constitute a separate offense.

430.751 Failure to Comply with Order of the Board of Health

Any person who fails to comply with an order issued pursuant to this chapter shall upon conviction be fined not less than ten, nor more than one hundred dollars in accordance with M.G.L.c. 140, s. 32E. This may be enforced by the Medford Board of Health once all necessary notifications and procedures are followed. A person shall be subject to a fine of fifty dollars (\$50.00). Each day that the offense continues shall constitute a separate offense.

430.752 Failure to Comply with Provisions of this Code

Any person who shall violate any provision of these regulations shall upon conviction be fined not less than ten, nor more than one hundred dollars in accordance with M.G.L.c. 140, s. 32E. This may be enforced by the Medford Board of Health once all necessary notifications and procedures are followed. A person shall be subject to a fine of fifty dollars (\$50.00). Each day that the offense continues shall constitute a separate offense.

400.700 Penalties

(C) (1) These regulations may be enforced by the Medford Board of Health once all necessary notifications and procedures are followed. A person shall be subject to a fine of fifty dollars (\$50.00). Each day that the offense continues shall constitute a separate offense.

Ticket Enforcement under M.G.L. c. 40 s 21D:

590.051 (B) (1) These regulations may be enforced by the Medford Board of Health through Ticket Enforcement under M.G.L. c. 40 s 21D:

Fine Schedule:

First offense, fifty dollars (\$50.00);

Second offense, seventy-five dollars (\$75.00);

Third and subsequent offenses, one hundred dollars (\$100.00)

Each day that the offense continues shall constitute a separate offense.
