Job Description

The Security Officer enforces policies and procedures while ensuring the personal safety of students, staff, faculty, visitors, and property of Catherine Cook School. The Security Officer serves as the first point of contact to visitors entering the school and the last person most see as they leave. Additionally, through the monitoring of shared spaces across all campus buildings, this role is therefore critical in ensuring a positive image and maintaining safety for the school. The position reports to the Facilities Manager and includes, but is not limited to, the following responsibilities:

- Patrol and monitor all facilities and immediate surrounding areas to ensure the safety and well-being of all community members.
- Direct traffic during morning arrival and afternoon dismissals in accordance with the school's drop-off/pick-up procedures.
- Assist administrative staff, police, and emergency personnel during emergencies, disruptive situations, and drills, including fire drills, severe weather drills, lockdowns, etc.
- Notify the building administration, police, and/or appropriate emergency personnel of emergency situations, unauthorized visitors, acts of vandalism, and/or potentially dangerous/suspicious activity.
- Identify visitors and permit only authorized individuals eligible to enter the facility.
- Enforce the school's sign in/out procedures and provide direction to visitors.
- Display ethical and professional behavior in working with students, parents/guardians, caregivers, and school personnel.
- Advise administration on security and safety related issues.
- Maintain the security post at the front entrance during all school hours. Notify the main office when leaving post for any reason (restroom, rounds, etc.)
- Always maintain an attentive physical presence.
- Sign for/accept deliveries.
- Perform other job-related duties as assigned

Ideal candidates will possess:

- Minimum of high school diploma or equivalent required.
- Ability to exercise independent judgment.
- 2 years Armed Security, Law Enforcement, or U.S. Military experience.
- Must enjoy interacting with children.
- Must display ethical, professional, and age-appropriate behavior in interacting with students, parents, and school personnel.
- Ability to always maintain a calm and professional demeanor and to exercise good judgement in responding to traffic, security, safety, and emergency situations.
