Medically Verified Immunization Records

- Students new to the Issaquah School District and incoming Kindergarten students need to provide a medically verified immunization record at the time of registration.
- A medically verified record can come directly from the **Washington State Immunization Information System (WAIS)**.
- **The WAIS** is the database for Washington State and is where medically verified immunization information is maintained. All parents have access to this site to print a validated Certificate of Immunization (**CIS**) for students. Health Care Practitioner offices also have this information for their families.

Acceptable Immunization Documentation Includes ONE of the Following:

- A Certificate of Immunization Status (CIS) printed from the (WAIS)
- A physical copy of the State CIS form with a healthcare provider signature.
- A physical copy of the CIS with accompanying medical immunization records from a healthcare provider verified and signed by school staff
- A CIS printed from MyIR.

Required Immunizations for New Students

- 2 MMR's (measles, mumps and rubella) given in the appropriate time frames
- 5 doses of DTaP (diphtheria, tetanus & pertussis) given in the appropriate time frames
- 2 doses of varicella given in the appropriate time frames
- 4 doses of polio (IPV) given in a specific time frames
- 3 doses of Hepatitis B, given in the appropriate time frames
- 1 Tdap for students 7th grade and above
- Vaccines against COVID-19 are not required for school attendance.

30 Day Conditional Status from the First Day of Attendance no Longer in Effect

Students will need a completed CIS or **Certificate of Exemption (COE)** on file at school **before the first day of attendance.**

If students are missing doses, they will need to get **all the doses they are eligible** to receive **before** starting school. They can then attend school in a Conditional Status until the minimum valid date of the next vaccine is reached. They then have 30 calendar days to turn in documentation of having received the dose. This continues on until all vaccines have been administered and documented.

Example

- If a child has all their immunizations except the 2-dose MMR series, and they get dose 1 of the MMR the day before school starts and it is documented with the school that day, the child can enter school because...
 - Dose 2 of the MMR cannot be given until 28 days after the first dose.
 - Beginning on day 29 after the first dose, the child has 30 days to get MMR dose #2.

MY CHILD IS NOT 5 YEARS OLD YET...

Children can receive their school immunizations at age 4. Contact your healthcare provider to schedule your appointment.



We are moving from another state and cannot find our immunization records. Now what?

- Immunization records from another state's immunization registry are accepted as medically verified records.

OR

- Call your provider in the state you moved from and have them send the immunization records directly to the school either by fax or by email.

We are moving from another country and cannot find our child's immunization records. What do we do?

- Immunizations verified by the Immigration Dept are accepted
- If possible, contact the provider in your first country via email or phone to have them send you the records
- Get established with a provider in this country. They can order lab titers to be drawn which will determine if your child has immunity to the different diseases.

SUMMARY of IMMUNIZATION INFORMATION

- Your student may register for school, but MAY NOT attend school until provider-verified immunizations have been received and validated by the school nurse.
- The child must have all immunizations they are eligible to receive prior to starting school.
- Or there is a **Certificate of Exemption** on file signed by the parent AND the licensed healthcare provider.

Please Notify the School if your Child has a Life-Threatening Health Condition such as:

- A severe allergy for which an epinephrine auto injector device (Epipen™) has been prescribed.
- Diabetes
- Severe asthma
- A seizure disorder
- A cardiac condition
- Adrenal Insufficiency
- Other conditions of concern

Why does the school need to know if my child has one of these conditions?

- If your child has a life-threatening condition, WA state law says there must be an emergency care plan and any associated medication in place in the school building before the child can attend school.
- This is to keep the student safe in the event they experience a medical emergency during the school day.
- If your child has a life-threatening condition, please contact the school nurse in your child's school before the student attends.

FAQs

Issaquah School District Kindergarten FAQ's 2023-2024 School Year

Q: Which schools will offer free Full Day Kindergarten?

A: All schools offer free full day kindergarten to all eligible incoming students.

Q: Where do I register?

A: Registration is online. Once you have filled out the online portion, you will be required to complete the registration process at your neighborhood school. The kindergarten registration window begins in early February and concludes March 3rd. Each neighborhood school has designated specific dates as to when kindergarten registration activities take place.

Q: May I register my child after March 3rd?

A: Yes, however, we set the registration window in order to get an enrollment count to help the Issaquah School District (ISD) determine staffing and classroom needs for the next year. Again, registration occurs at your neighborhood school.

Q: How old does my child need to be to register?

A: Incoming kindergarten students must be at least 5 years old by August 31 in order to register for kindergarten.

Q: Can I register him/her if they do not turn 5 by August 31?

A: No. However, students who will turn 5 by November 30, are eligible to apply for Early Entrance. The students must complete independent testing by a qualified outside assessor, meet district Early Entrance requirements by July 15, 2022 and eligibility be confirmed by the Office of the Executive Directors of Elementary Education.

Q: What do I need to register?

A: Immunization records, proof of birth date such as a copy of the birth certificate or passport, and proof of home address such as a purchase or lease agreement and an energy utility bill and photo I.D. of the parent/guardian are necessary for registration.

Q: What are the bell times for Full Day Kindergarten?

A: Students in full day kindergarten follow the same schedule as grades 1 through 5 in their neighborhood school (or school of attendance).

Q: Do Full-Day Kindergarteners ride the bus?

A: Yes, full day kindergarten students will ride the same bus as the other students attending their neighborhood school (or school of attendance).

Q: Is Half-Day Kindergarten (morning only) an option for my child?

A: Yes, half-day kindergarten students would attend for three hours in the morning.

Q: What are the bell times for the Half Day Kindergarten (morning only) option?

A: Half-day (morning only) kindergarten students will begin the day on the same bell schedule as all students attending their neighborhood school (or school of attendance). Students in the half day session will attend for three hours in the morning.

Q: Do half day kindergarteners ride the bus?

A: Yes, half day kindergarten students will ride the same bus in the morning as the other students in their neighborhood (or school of attendance). Mid-day transportation will not be provided by the district. Parents/guardians will be responsible for picking their child up at the end of the three hour half day morning session.

Welcome to the Issaquah School District

Washington State law requires all students to be fully immunized **before** attending school. Recent changes to WA State law are:

1. A personal, medical or religious exemption to immunizing your child requires the signature of a parent/guardian and a licensed health care provider.
2. Personal/philosophical exemptions are **not** allowed for the measles, mumps & rubella (MMR) vaccine.
3. Immunization records for school and childcare entry must be medically verified. Medically verified record includes one or more of the following:
 - A Certificate of Immunization Status (CIS) printed from the Immunization Information System (IIS)
 - A physical copy of the CIS form with a healthcare provider signature
 - A physical copy of the CIS with accompanying medical immunization records from a healthcare provider verified and signed by school staff

If your child has received immunizations in Washington State, please access their Certificate of Immunization Status (CIS) electronically through the Washington State Immunization Information System at: <https://wa.myir.net/>

If you have not accessed this site before, you will need to register on the site to print the CIS.

If you cannot access a CIS form, you may fill out one manually and then show it with provider proof of immunizations to the school nurse.

If you cannot locate your child's immunization records, please contact your licensed healthcare provider, or your student's previous school. Once the completed Certificate of Immunization form has been received at the school and verified by the school nurse, your student may attend school.

Immunizations can be provided by your healthcare provider or local pharmacy. If you do not have a healthcare provider or medical insurance, contact the resources listed below.

Schedule a meeting with your school nurse if you are requesting an exemption form. Your student **MAY** register for class but **MAY NOT** attend school until all immunization requirements are met, or, there is a Certificate of Exemption on file signed by the parent and the licensed healthcare provider.

To: Parents of Children with Special Health Care Needs

Re: Requirements for a medication or treatment order and a health care plan to be in place prior to attending school.

The purpose of this letter is to inform you of WA State Law RCW 28A.210.320 titled, "Children with life-threatening health conditions – Medication or treatment orders –Rules."

The law defines a life-threatening condition as, "A health condition that will put the child in danger of death during the school day if a medication or treatment order and a nursing plan are not in place." Some common life-threatening conditions are:

- Severe allergies that have an EpiPen™ prescribed
- Severe asthma
- Diabetes
- Epilepsy (a seizure disorder)
- Cardiac conditions
- Adrenal insufficiency

Students with these conditions must have a medication or treatment order and nursing care plan in place before they start school. The medication or treatment order must be from the child's licensed health care provider.

If a current medication or treatment order is not provided, the chief administrator of the school is required to exclude the child until such order has been provided. This requirement applies to students with a life-threatening condition who are new to the district, and to students who are already enrolled in the district. Our exclusion procedures are in accordance with the rules (WAC's) of the State Board of Education.

RCW 28A.210.330 requires that all children with diabetes have an individualized health care plan and supplies in place before entering school.

It is vital to your child's safety during the school day that if your child has one of the life-threatening health conditions listed above, immediately notify your School Nurse.

If your child has any health condition that could be considered life-threatening such as asthma, food allergies with an EpiPen™ prescription, seizures, diabetes, etc. please fill out the following form. According to the law, your child must have an emergency health plan, which includes medication orders from your child's health care provider in place before he/she can attend school. The emergency health plan with necessary orders and medications must be to your child's school on **August 16, 2022**, for this important information to be processed. Please return this form to your school nurse as soon as possible.

You may also fill out this form if your child has any health condition that you would like the school to be aware of, even if it isn't life-threatening.
