551.076 Discussing a security audit, and the deployment, specific occasions for, or implementation of, security personnel or devices.

Should any final action, final decision, or final vote be required in the opinion of the Safety and Security Committee with regard to any matter considered in such closed or executive meeting or session, then the final action, final decision, or final vote shall be either:

- (a) in the open meeting covered by the Notice upon the reconvening of the public meeting; or
- (b) at a subsequent public meeting of the Safety and Security Committee upon notice thereof as the Safety and Security Committee shall determine.
