#### Message from the Mayor



Hello everyone, and happy summer!

It has been a busy few weeks and months here in Medford. Together with members of the community, our departments have been hard at work advancing our shared goals and values and we have so much to share with you.

Most recently, I am extremely happy and thankful that we reached an agreement with the City Council on June 28th and my proposed Fiscal Year 2023 budget was unanimously approved by all seven councilors.

There is still so much to do and we're still facing economic shortfalls due to the lingering effects of the global pandemic on our finances—but this is great news.

Thank you to the City Council for advocating for their priorities and working with me and my team to reach a compromise and for passing this budget, and a special thanks to our department heads and especially my Chief of Staff, Nina Nazarian, for working so tirelessly over the last few weeks and months to help us present a responsible, balanced budget.

While we faced financial challenges through this process, we allocated additional funding to the library to support increased staffing and maintenance needs in the new building, we allocated an additional \$300,000 in ARPA funding to the Medford Public Schools budget on top of a 2.5 percent overall increase to the school budget, and we continued our investment in our parks and open spaces, stump removals and tree plantings, affordable housing, climate resiliency, and so much more.


Mayor Establishing Committee to Study City's Charter

Like most cities and towns, Medford has rodent activity on both public and private property. To be effective in addressing this issue, we are asking residents and businesses to help by making sure all



The City's residential Shared Streets program is returning, by resident request.

Shared streets are temporary interventions with cones and signage to give people more space to get around in their neighborhoods car-free and safely. Local traffic, deliveries, and emergency vehicles will still have access to the street, but these interventions discourage cut-through traffic and prioritize the safe use of streets for pedestrians and bicyclists.

### City Working with 40B Applicants + External Partners to Expand Affordable Housing Options



been issuing tickets, accepting payments and granting permits to residents and visitors for over two months and with the process in full swing, the City is providing an update to residents on parking procedures and violations.

Beginning July 1, the City will be issuing yearly parking permits on a pro-rated basis for 2022. In the past, permits were issued for an entire calendar year based on the date in which it was purchased. In an effort to streamline this process, the City's parking department will be offering a reduced rate for people buying permits this late into the year. For example, a permit issued on July 1 will be valid until December 31, 2022 but offered at a discounted price.

# Reminder: Plan Ahead for Fall Street Sweeping!

We're still a few months away from the "Big Sweep" fall street sweeping, but it's never too early to plan ahead!

As a reminder, the "Big Sweep" is conducted on all side streets twice each year - once in the spring and once in the fall. Usually beginning in mid-November and continuing for approximately 3 weeks, the Medford DPW will conduct street sweeping on all secondary roads in the city. During scheduled street sweeping, street parking is restricted on the day your street is assigned to be swept. Plan ahead by making sure you're signed up for city alerts at www.medfordma.org/alerts,

### **Business + Development**

Medford's development potential is huge, and developers in large sectors such as life sciences, manufacturing, biotech, and retail marijuana establishments are taking notice thanks to the efforts of our Economic Development Director and the Office of Planning, Development, and Sustainability. While continuing to protect and enhance residential neighborhoods, Medford's primarily commercial areas such as Mystic Ave. and portions of Mystic Valley Parkway are poised for new growth and strategic development that will put Medford on the map, increase our commercial tax base, and bring in new jobs and revenue to the city.

Over the last decade Medford's commercial tax rate was decreasing, when so many of these factors meant we could and should be investing more and attracting the kinds of smart development that could increase our commercial tax rate, lessen the burden on residential taxpayers, bring in more jobs and revenue, and bolster the city's financial stability. I am so proud of the work we have been able to accomplish in just over two years to make this a reality.

In the last 18 months, the Economic Development team has successfully attracted several potential developers from the life science industry, set up, managed, and saw the successful culmination of a Cannabis Advisory Committee that has already resulted in one Host Community Agreement (HCA) with another to follow within weeks, and discussions for a third retail HCA and a cultivation HCA currently in process. These HCAs will bring huge community benefits - such as a community arts center - to Medford along with important revenue.

Here are a few of our most recent updates:

## Life Science Development

Two life science developments are currently under construction, with up to eight other potential developers in planning phases, totaling a possible 1.5 million square feet. The Office of PDS has proposed zoning changes to existing industrial areas to encourage biotech and life science development. These could improve large areas of the city that are designated industrial and currently allow only for low-rise buildings with large surface parking lots.

The City is also working with MassBIO to be designated as a "bio-ready" community, a list developed by the organization to help encourage the expansion of biotech in the region.

### **Host Community Agreements**

In June, Mayor Lungo-Koehn signed the City's second Host Community Agreement with a recreational marijuana dispensary. Medford voters approved recreational marijuana dispensaries (with regulations) in a citywide election in November 2016. The City Council began working on an ordinance in 2016 and approved zoning amendments to support the siting of these dispensaries, in September 2020, with a vote to adopt a Cannabis Advisory Committee in November 2020. A Committee was convened and began its process in February 2021 with final recommendations submitted in Fall 2021. The Mayor signed the first CHA in early March.

These HCAs will bring huge community benefits - such as a community arts center to Medford along with important revenue.

### Wellington Area RFI

This summer the City is launching a Request for Information from large scale developers about what they hope to see in the area surrounding the Wellington MBTA station. Per an act of the legislature, Medford owns the air rights to these areas and we want to see which kinds of developers are interested in pursuing projects here to better inform how we move forward.

#### **Façade Improvement Program**


This spring, the City's Office of Planning, Development, and Sustainability launched a matching grant program for new and existing small businesses looking to make façade improvements. The program is intended to enhance the exterior appearance of commercial spaces and attract new customers and patrons to the City's local business scene.

The city anticipates opening a second

round of funding in the fall, subject to available funds.

## Planning + Sustainability



Medford continues to lead on climate, energy, and environmental initiatives. Earlier this year, thanks to the very hard work by staff in the Office of Planning, Development, and Sustainability, we released a comprehensive Climate Action and Adaptation Plan. The plan sets new goals for future efforts, like expanding renewable energy sources, and providing tools for property owners and tenants to prepare for climate hazards. It also expands on ongoing work like protecting and growing our tree canopy, investing in stormwater maintenance, addressing food insecurity and increasing local food system resilience.

Collectively, the 32 strategies in this plan detail the key steps that will enable us to reduce greenhouse gas emissions to net zero by 2050, build our resilience to growing climate hazards, advance environmental justice, and create a city where all residents can benefit from a more sustainable future.

We have made substantial progress in mitigating the effects of climate change but with the help of this plan we are taking real steps to ensure that Medford is a leader in climate action. While the plan sets short- and long-term goals, we have already been working to address climate change and prepare the community for a green and renewable future by:

- Installing solar panels at DPW, Library, and Police Station
- Updating lighting at some municipal facilities to LED
- Expanding the City's tree canopy
- · Working to update the city's stormwater regulations
- Installed 19 micro food pantries
- Launching a curbside composting program

- Installing Medford's first dedicated bus lane on Mystic Ave.
- Bringing a bike share program to Medford (in process)
- Expanding/adding dedicated bike lanes citywide
- Expanding EV charging stations citywide with Hormel as our newest location

### Coming Soon: Blue Bikes!

We recently received three grants to implement BlueBike stations throughout Medford, and we have already worked with private employers who plan to host stations. We have been working with several of our surrounding communities to negotiate new stations and, once the contract is complete hopefully in the very near future, we are fully prepared to launch stations as soon as possible. Potential sites will be assessed based on proximity to dense employment centers, residential neighborhoods, commercial centers, high-traffic bicycle/pedestrian facilities, and key public transit nodes.
