

## Birmingham Community Charter High School Banda Dance Guest Contract March 24, 2023 – BCCHS P.E. Field

This contract signed by you and your parent/guardian is required prior to purchasing a ticket and attending the BCCHS Banda dance with a guest. The contract must be signed by the student and parent/guardian as well as an administrative representative from his/her school. A copy of the guest's current photo ID and school assistant principal approval is also needed. There will be NO REFUNDS. *Please review ALL information carefully before signing.* Deadline for contract is 3/13.

All students and guests are expected to abide by the rules of Birmingham Community Charter High School. The use of tobacco, drugs, or alcohol are prohibited prior to and while in attendance at the dance. Possession will result in appropriate disciplinary action including, but not limited to being ineligible to participate in other school sponsored activities, placed on the NO GO list, suspension from school and/or arrest by the SCHOOL POLICE DEPARTMENT. You and your guest, if suspected of being under the influence, will be subject to BREATHALYZER testing and/or escorted out of the dance. Refunds will NOT be granted.

Students & Guests MUST bring a photo identification card with them to the dance. BCCHS students must bring their student ID. Guest identification can be a valid school student body identification card, a valid California Driver's License, or a valid DMV issued identification card. Guest cannot be over 20 years of age. No middle school students allowed. BCCHS student and guest enter the dance as a couple.

**Dance Time**: 6pm-10 pm, 8 pm is the final check-in time. There are no ins and outs. Students are not allowed to leave the dance and the return. Students are expected to be picked up within 15 minutes of the end of the dance.

Dress Code: Students are expected to follow Birmingham Community Charter High School dress code as well as not bring any items on the prohibited dance items list found on the school's website.

Ticket Policy: All financial obligations and overdue library/textbooks must be cleared prior to purchasing tickets. Students cannot be on the NO GO list. All tickets must be purchased from the Student Store window. All tickets are sold to specific individuals with signed contracts. TICKETS MAY NOT BE GIVEN, SOLD, OR EXCHANGED TO OTHER STUDENTS. NO REFUNDS will be given to anyone for any reason prior to or after the dance. NO REFUNDS will be given to students who do not show up to the dance or are not allowed to enter the dance for any reasons stated on this contract. NO TICKETS will be sold at the door.

**Dance Policies**: No inappropriate contact. You may not pick up another student. When hands are placed on another's body, they should be in appropriate places, such as the waist or shoulders. ANY dancing or movement that implies ANY sexual activity OR motion is forbidden.
